24	The Department of Parking and Traffic shall place and maintain, or cause to be placed

- (a) Any vehicle which is subject to the provisions of Sections 1031 to 1036, inclusive, of the Public Utilities Code of the State of California <u>and which has received a</u> <u>certificate from the Public Utilities Commission of the State pursuant to those Sections declaring that the public necessity and convenience require the operation of the vehicle, provided that the certificate authorizes that vehicle to be operated in the City and County of San Francisco, and the vehicle is being operated for the purpose authorized in the certificate. This exemption shall not apply to vehicles operated as round-trip sight-seeing tour service as defined by the Public Utilities Commission;</u>

- (d) Transit vehicles operated by the Municipal Railway along a regularly scheduled route;
 - (e) School buses when operated for the transportation of school pupils;
