11	WHEREAS, the Planning Department for the City and County of San Francisco (the
12	"Department") determined that an Environmental Impact Report ("EIR") was required
13	(Planning Department File No. 2001.0636E) and provided public notice of that determination

14	WHEREAS, On October 15, 2005, the Department published the Draft Environmental
15	Impact Report ("DEIR") for the Project; and

18	and written comments were received through November 29, 2005; and
19	WHEREAS, The Department prepared responses to comments received at the public
20	hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text
21	of the DEIR and published a Draft Summary of Comments and Responses on June 5, 2006;

24	WHEREAS, A Final Environmental Impact Report ("FEIR") for the Project was
25	prepared by the Department, consisting of the DEIR, any consultations and comments

2	Draft Summary of Comments and Responses, all as required by law; and
3	WHEREAS, On June 22, 2006, the Commission reviewed and considered the FEIR
4	and, by Motion No. 17274, found that the contents of said report and the procedures through
5	which the FEIR was prepared, publicized and reviewed complied with the provisions of the
6	California Environmental Quality Act ("CEQA"), the State CEQA Guidelines and Chapter 31 of
7	the San Francisco Administrative Code; and
8	WHEREAS, By Motion No. 17274, the Commission found the FEIR to be adequate,
9	accurate and objective, reflected the independent judgment and analysis of the Department
10	and the Commission and that the Summary of Comments and Responses contained no
11	significant revisions to the DEIR, adopted findings relating to significant impacts associated
12	with the Project and certified the completion of the FEIR in compliance with CEQA and the
13	State CEQA Guidelines; and
14	WHEREAS, On July 6, 2006, on behalf of F. Alioto Fish Company, David Cincotta filed
15	an appeal of the FEIR with the Clerk of the Board of Supervisors; and
16	WHEREAS, The Board of Supervisors held a public hearing on August 1, 2006, to
17	review the decision by the Planning Commission to certify the FEIR; and
18	WHEREAS, the FEIR files and all correspondence and other documents have been
19	made available for review by the Board of Supervisors, the Planning Commission and the
20	public; these files are available for public review by appointment at the Planning Department
21	offices at 1660 Mission Street, and are part of the record before the Board of Supervisors; and
