3	Ordinance amending the S.F. Park Code by renaming Article 1 as "Title and General
4	Provisions" and adding, Section 1.05 to rename the area now known as Ferry Park as
5	Sue Bierman Park.

9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. Findings.
11	Sue Bierman passed away on August 7 <sup>th</sup> , 2006 at the age of 82. She worked tirelessly
12	on behalf of the people and neighborhoods of San Francisco to preserve the City's character
13	and livability. Sue Bierman served with distinction on the City's Planning Commission for 24
14	years, on the Board of Supervisors for 8 years, and on the Port Commission for 3 years. She
15	was instrumental in the successful fight against the construction of the Central Freeway
16	project which would have built a freeway through Golden Gate Park. During her tenure on the
17	Planning Commission, an active defender of the City's historic structures and streetscapes in
18	the face of new development, and champion of the rights of tenants and the poor. Thanks to
19	her leadership on issues of affordable housing, access to quality healthcare for City residents,
20	and preservation of existing open space in the City, San Francisco is a more livable and
21	compassionate city today. Block 202 of the City's Master Plan, the site of former freeway
22	ramps off Embarcadero between Clay and Washington, is the only park of trees and grass in
23	the financial district and is preserved as open space today thanks to the tireless efforts of Sue
24	Bierman. It is a particularly fitting tribute to honor Sue Bierman with a park she helped save
25	from development.

1	Ordinarily, the Recreation and Park Commission names property under its jurisdiction,
2	but given the sudden and tragic passing of Sue Bierman, the Board Of Supervisors wishes to
3	honor their colleague with this naming.
4	Section 2. The San Francisco Park Code is hereby amended by renaming Article 1 as
5	"Title and General Provisions" and adding Section 1.05, to read as follows:
6	SEC. 1.05. SUE BIERMAN PARK.
7	The area known as "Ferry Park" across from the Ferry Building at the eastern terminus of
8	Market Street shall be known as Sue Bierman Park.
