

1 [Parking Regulations.]

3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

9 Kearny Street, west side, from Broadway to 79 feet southerly.

10 **PARKING METER AREA NO. 3 (2-HOUR PARKING TIME LIMIT, 9 AM - 6 PM, MONDAY**
11 **THROUGH SATURDAY) - ESTABLISH**

12 Folsom Street, both sides, between 5th and 6th Streets; and,

13 South Van Ness Avenue, both sides, between Mission and Howard Streets.

14 **NO PARKING ANYTIME - ESTABLISH**

15
16 Market Street, west side, from the light pole, approximately 100 feet south of the
17 driveway of 3550 Market Street to the driveway of 3620 Market Street (due to
the absence of a sidewalk).

18 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

19 Folsom Street, north side, from 138 feet to 188 feet east of 2nd Street.

20 **RESIDENTIAL PERMIT PARKING AREA "U" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
21 **MONDAY THROUGH FRIDAY) - ESTABLISH**

22 Gilbert Street, both sides, between Brannan Street to southern terminus (unit block,
23 excludes Lot #18, block 3784).

24 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

1 Leavenworth Street, east side, from the south side of the driveway of 808 Leavenworth
2 Street to 20 feet southerly (20-foot space, accommodating 4 motorcycle parking
spaces).

3 **PARKING METER AREA NO. 2 (1-HOUR PARKING TIME LIMIT, 7 AM - 6 PM, MONDAY**
4 **THROUGH SATURDAY) - ESTABLISH**

5 Natoma Street, south side, between 5th and Mary Streets (portion of the 400 block)

6 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

7 Webster Street, along the terminus, south of Hermann Street (Unit Block); and,

8 Webster Street, east side, from the terminus to 29 feet northerly (Unit Block).

9 **NO PARKING ANYTIME - ESTABLISH**

10 101 Lansdale Avenue, from 97 feet north of the southeast property line of 101
11 Lansdale Avenue to 112 feet west of the northeast property line of 101 Lansdale
12 Avenue (along the inside of the curve adjacent to 101 Lansdale Avenue).

13 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

14 Pennsylvania Avenue, east side, from 23rd Street to 350 feet northerly.

15 **PARKING METER AREA NO. 2, 7AM TO 6PM, 1-HOUR TIME LIMIT, MONDAY THROUGH**
16 **SATURDAY - ESTABLISH**

17 Market Street, north side, from 12th Street to Van Ness Avenue (within the parking bay
18 area).

19 **TOW-AWAY NO STOPPING ANYTIME - ESTABLISH**

20 Market Street, north side, from Page Street to 12th Street.

21 **RESIDENTIAL PERMIT PARKING AREA "U" – RESCIND**

22 45 Lansing Street, Lot 59 of Block 3749 on the Unit block of Lansing Street.

23 Categorically exempt from Environmental Review Class
24 1(c)(9) changes in the traffic and parking regulations where
such changes do not establish a higher speed limit or result in
25 more than a negligible increase in the use of the street.
