The official or secretary shall-also inform the department head of the necessity to file within 30 days onof assuming office or leaving office a statement of economic interests. Upon receiving notice of the appointment, or the resignation or retirement, of the department head, the Ethics Commission shall perform the required duties of the filing officer and obtain the required statement of economic interests.
