1	[Preparation of findings to disapprove certification of San Francisco Marina Renovation FEIR]
2	
3	Motion directing the Clerk of the Board to prepare findings disapproving the
4	certification by the Planning Commission of the Final Environmental Impact Report for
5	the San Francisco Marina Renovation Project FEIR.
6	
7	WHEREAS, The San Francisco Recreation and Park Commission (the "Project
8	Sponsor") is proposing to renovate the San Francisco Marina, located north of Marina
9	Boulevard between Lyon and Laguna Streets (the "Project"); and
10	WHEREAS, The Project Sponsor applied for environmental review to the Planning
11	Department for the City and County of San Francisco (the "Department") (City Planning File
12	No. 2002.1129E) and on December 27, 2003, the Planning Department published a
13	preliminary negative declaration; and
14	WHEREAS, Following several appeals, the Department determined that an
15	Environmental Impact Report ("EIR") was required and provided public notice of that
16	determination by publication in a newspaper of general circulation on October 9, 2004; and
17	WHEREAS, On September 6, 2005, the Department published the Draft Environmental
18	Impact Report ("DEIR") for the Project; and
19	WHEREAS, On October 6, 2005 and January 12, 2006, the Planning Commission for
20	the City and County of San Francisco (the "Planning Commission") held duly noticed public
21	hearings on the DEIR, at which time opportunity for public comment was received on the
22	DEIR, and written comments were received through January 20, 2006; and
23	WHEREAS, The Department prepared responses to comments received at the public
24	hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text
25	

of the DEIR and published a Draft Summary of Comments and Responses on September 28,
 2006; and

3 WHEREAS, The Department prepared a Final Environmental Impact Report ("FEIR") 4 for the Project, consisting of the DEIR, any consultations and comments received during the 5 review process, any additional information that became available and the Draft Summary of 6 Comments and Responses, all as required by law; and

WHEREAS, On January 11, 2007, the Planning Commission reviewed and considered
the FEIR and, by Motion No. 17357, found that the contents of said report and the procedures
through which the FEIR was prepared, publicized and reviewed complied with the provisions
of the California Environmental Quality Act ("CEQA"), the State CEQA Guidelines and

11 Chapter 31 of the San Francisco Administrative Code; and

12 WHEREAS, By Motion No. 17357, the Planning Commission found the FEIR to be 13 adequate, accurate and objective, reflected the independent judgment and analysis of the 14 Department and the Commission and that the Summary of Comments and Responses 15 contained no significant revisions to the DEIR, adopted findings relating to significant impacts 16 associated with the Project and certified the completion of the FEIR in compliance with CEQA 17 and the State CEQA Guidelines: and 18 WHEREAS, On January 18, 2007, the Recreation and Park Commission adopted 19 CEQA Findings and approved the Marina Renovation Project; and 20 WHEREAS, On January 31, 2007, Howard Strassner, on behalf of San Francisco 21 Group of the Sierra Club filed an appeal of the FEIR with the Clerk of the Board of 22 Supervisors; and

WHEREAS, The Board of Supervisors held a public hearing on February 27, 2007, to
 review the decision by the Planning Commission to certify the FEIR; and

8	the basis for its disapproval of the certification of the FEIR by the Planning Commission.
