3	Resolution approving the Fixed Base Operator Lease and Operating Agreement
4	between Signature Flight Support Corporation and the City and County of San
5	Francisco, acting by and through its Airport Commission.

7	WHEREAS, The Airport Commission authorized the issuance of a Request for Proposal
8	for the Fixed Base Operator Lease and Operating Agreement; and
9	WHEREAS, A five member panel reviewed and rated the qualifying proposal and oral
10	presentations in accordance with the Commission-approved selection criteria; and
11	WHEREAS, The panel determined that Signature Flight Support Corporation submitted
12	the superior proposal, with an initial Minimum Annual Guarantee of \$11,000,000 for the first
13	Lease Year or the sum of the following percentage rent: (1) 100% of all Landing Fees, (2) 27%
14	of all Fuel Sales, (3) 55% of all Aircraft Parking, (4) 40% of all Advertising, (5) 26% of Other
15	Gross Revenues, and (6) 1% of Fixed Fees for Aircraft Sales, whichever is greater; and
16	WHEREAS, On May 15, 2007, pursuant to Resolution No. 07-0106, the Airport
17	Commission approved the award of the Fixed Base Operator Lease and Operating Agreement
18	between Signature Flight Support Corporation and the City and County of San Francisco; and
19	WHEREAS, A copy of the form of the Lease is on file with the Clerk of the Board of
20	Supervisors in File No, which is hereby declared to be a part of this resolution
21	as if set forth fully herein; now, therefore, be it
22	RESOLVED, That the Board of Supervisors hereby approves the award of the Fixed
23	Base Operator Lease and Operating Agreement to Signature Flight Support Corporation for a
24	ten (10) year term with an initial Minimum Annual Guarantee of \$11,000,000 or the sum of the
25	following percentage rents: (1) 100% of all Landing Fees, (2) 27% of all Fuel Sales, (3) 55% of
