12	Section 1. The Board of Supervisors adopts as its own and incorporates by reference		
13	herein as though fully set forth the Planning Department findings in its letter dated December		
14	13, 2006, Said letter stated that the actions contemplated herein are consistent with the		
15	General Plan and in conformance with the Eighth Priority Policies of Planning Code Section		
16	1011. A copy of said letter is in the Clerk of the Board of Supervisors File No.		
17	Section 2. In the abovementioned letter, the planning Department also determined that		
18	the actions contemplated in this Ordinance are in compliance with the California		
19	Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said		
20	determination is incorporated herein by reference.		
21	Section 3. In accordance with the Department of Public Works' Order No. 176,789, a		
22	copy of which is in the Clerk of the Board of Supervisors File No. , Board of Supervisors		
23	Ordinance No. 1061, entitled "Regulating the Width of Sidewalks," a copy of which is in the		
24	Clerk of the Board of Supervisors Book of General Ordinances, in effect May 11, 1910, is		
25	hereby amended by adding thereto a new section to read as follows:		

1	Section 1574. The official sidewalk width on the northerly side of Jessie Street westerly of Ecke		
2	Street shall be as shown on Department of Public Works drawing Q-20-641, a copy of which is in the		
3	Clerk of the Board of Supervisors File NO		
4	Section 4. The Golden Gate University, as is necessary as a result of this Ordinance,		
5	shall make arrangements with public utility companies and City departments concerning		
6	relocation, modification, or any affect public facilities. Any required relocation, modification, o		
7	both of said facilities shall be at no cost to the City and County of San Francisco.
