1	[Urging Taxicab companies not to increase the number of long-term leases of medallions.]
2	
3	Resolution urging taxicab companies not to increase the number of long-term leases
4	of taxicab medallions or taxicabs in their fleets, urging the Taxi Commission to
5	strictly enforce Ordinances and Regulations requiring Proposition K medallion
6	holders to drive the taxicab permitted under their medallion and providing that the
7	Board of Supervisors shall consider regulation of long-term leasing.
8	
9	WHEREAS, Yellow Cab Cooperative ("Yellow") and Luxor Cab Company
10	("Luxor") have notified their drivers of their intention to phase out the leasing of
11	taxicabs by the shift and henceforth to exclusively enter into long-term leases with
12	drivers; and
13	WHEREAS, The Taxi Commission has forwarded to the Board of Supervisors a
14	recommendation for a taxi driver health-care plan, to be partially financed through
15	contributions from cab companies; and,
16	WHEREAS, Yellow and Luxor have stated in their notices to drivers that one reason
17	for changing their leasing arrangements to long-term leases is the impending health-care
18	plan; and,
19	WHEREAS, Yellow and Luxor have further stated in their notices to drivers that long-
20	term leases will cost drivers between \$2,900 and \$7,300 per month; now, therefore, be it
21	WHEREAS, Yellow and Luxor are the largest cab companies in San Francisco, and
22	other cab companies are likely to follow their lead; and
23	WHEREAS, Shift leases are regulated by the City and County of San Francisco, while
24	long-term leases are not currently regulated; and
25	

1	WHEREAS, The long-term leasing of medallions issued under Proposition K of 1978
2	could violate the intent and spirit of that ordinance; and
3	WHEREAS, Proposition K, the Police Code and Taxicab Rules and Regulations
4	require medallion holders to drive the taxicab permitted under their medallion while fulfilling
5	the Proposition K driving requirement; and
6	WHEREAS, Failure of medallion holders to drive the taxicab permitted under their
7	medallion facilitates long-term leasing; and
8	WHEREAS, An expansion of long-term leasing is not in taxi drivers' interests in that it
9	will eliminate large numbers of jobs and force many drivers out of the industry or into financial
10	arrangements they cannot afford; and
11	WHEREAS, An expansion of long-term leasing is not in the public interest in that it will
12	reduce the availability of taxicabs and place in jeopardy the viability of a taxi driver health-care
13	plan; and
14	WHEREAS, An expansion of long-term leasing is not in the interests of the City and
15	County of San Francisco, in that long-term-lease arrangements are more difficult to monitor
16	and regulate, more easily lend themselves to abuse, and place financial and operational risks
17	and burdens on taxi drivers that should be the responsibility of cab companies and medallion
18	holders; and
19	WHEREAS, Regulation of long-term leasing is necessary for purposes of protecting
20	the interests of the City, the public and drivers working under such arrangements; now,
21	therefore, be it
22	RESOLVED, That the Board of Supervisors urges Yellow, Luxor and other cab
23	companies not to increase the number of long-term leases of taxicab medallions or taxicabs
24	before the Board has the opportunity to consider regulation of long-term leasing; and be it

1	FURTHER RESOLVED, That the Board of Supervisors urges the Taxi Commission to
2	strictly enforce provisions of Proposition K, the Police Code and Taxicab Rules and
3	Regulations requiring medallion holders to drive the taxicab permitted under their medallion
4	while fulfilling the Proposition K driving requirement; and be it
5	FURTHER RESOLVED, That the Board of Supervisors shall consider regulation of
6	long-term leasing arrangements, to wit: reporting requirements for companies and medallion
7	holders operating medallions under long-term leases; restrictions on the expansion of long-
8	term leasing; standardization of long-term lease agreements; a cap on the amount of such
9	leases; protection for drivers currently holding long-term leases from arbitrary cancellation of
10	such leases; and a sunset on long-term leasing of Proposition K medallions.
