Section 1. Findings.			
(a) The Planning Department has determined that the actions contemplated in this			
ordinance comply with the California Environmental Quality Act (California Public Resources			
 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of			
 Supervisors in File No. 181045 and is incorporated herein by reference. The Board affirms			
 this determination.			
(b) On January 17, 2019, the Planning Commission, in Resolution No. 20369, adopted			
findings that the actions contemplated in this ordinance are consistent, on balance, with the
