3	Resolution to support extinguishing all non-essential lighting in all city government
4	buildings, public schools and public landmarks for the hour between 7:00 PM and 8:00
5	PM on October 20, 2007 to conserve energy as part of the city-wide energy
6 7	conservation event: Lights Out San Francisco, and establishing October 20, 2007 as
8	Lights Out San Francisco Day.
9	WHEREAS, San Francisco's greenhouse gas emissions target is a 20% reduction
10	below 1990 levels by the year 2012 and our community has taken a leadership position
11	demonstrating to the world that energy conservation is important and attainable; and,
12	WHEREAS, Lights Out San Francisco is a city-wide energy conservation event with
13 14	the goal of turning out all non-essential lighting in San Francisco for one hour and
15	encouraging each household to install one energy-efficient light bulb; and,
16	WHEREAS, Lights Out San Francisco will distribute free energy-efficient light bulbs to
17	residents throughout San Francisco prior to and on October 20; and,
18	WHEREAS, Turning off non-essential lighting for one-hour will result in a 10 to 15%
19	energy savings the night of the event; and,
20	WHEREAS, If every household installs one CFL, annual energy savings will reach
21	approximately 18 Gigawatt hours per year, or 1.3% of total residential energy demand; and,
2223	WHEREAS, The City of San Francisco is an internationally recognized leader in
24	environmental conservation action; and,

1	WHEREAS, Extinguishing non-essential lights in all city government buildings, public
2	schools and public landmarks for one hour will send a clear message to the world about the
3	importance of energy conservation and position San Francisco as a leader in the effort to
4	stop climate change; and,
5	WHEREAS, The city of Sydney, Australia turned out their lights for one hour, including
6	the lights on the Sydney Opera House, saving more than 24.86 tons of carbon dioxide – the
7 8	equivalent of taking 48,613 cars of the road for one-hour; and,
9	WHEREAS, Turning non-essential lights off in all city government buildings, public
10	schools and public landmarks will serve as an important rallying point for the city-wide energy
11	conversation event Lights Out San Francisco; and, therefore be it,
12	RESOLVED, That the City and County of San Francisco endorses Lights Out San
13	Francisco's efforts to conserve energy and raise awareness around global climate change;
14	and, be it,
15 16	FURTHER RESOLVED, That the City and County of San Francisco encourages all city
17	employees to turn off all non-essential lighting in city government buildings, public schools
18	and public landmarks for the hour between 7:00 and 8:00 PM on October 20, 2007 to
19	conserve energy and raise awareness about global climate change as part of the city-wide
20	energy conservation event: Lights Out San Francisco; and, be it,
21	FURTHER RESOLVED, That the San Francisco Board of Supervisors declares
22	October 20, 2007 to be "Lights Out San Francisco" day in the City and County of San
23	Francisco.
