3	Ordinance adding Section 95.2 to the San Francisco Administrative Code authorizing
4	the County Clerk to issue municipal identification cards upon request to residents of
5	the City and County of San Francisco.

9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. Findings.
11	(a) Many residents of the City and County of San Francisco - such as children and
12	youth, the elderly, homeless, immigrants, students, and transgender individuals - lack official
13	government-issued identification. Without an accepted form of identification, these City
14	residents are not able to participate in local commerce and other forms of civic engagement
15	such as opening a bank account or obtaining a library card.
16	(b) Residents' lack of access to acceptable forms of identification also raises public
17	safety concerns for the City. Residents without access to bank accounts often carry large
18	amounts of money on their person or store it in their home making them targets for crime. In
19	addition, residents who cannot produce proof of identity are often reluctant to report crimes to
20	the police that they suffer or witness. Studies show that immigrant populations in particular are
21	victimized by crime at rates similar to or greater than the general population but they report
22	crime at lower rates than the general population. This under-reporting of crime poses a

serious public safety problem and erodes the ability of law enforcement to function effectively

in the City.

1	(c) A San Francisco identification card would serve to reduce the impact of the above
2	conditions, improve public safety, and enable all of San Francisco's residents to participate
3	more fully in and become an integral part of the life of the community. A municipal
4	identification card would encourage crime reporting and witness cooperation, both key
5	elements in building a safer community. Such cards would also enable more City residents to
6	open bank accounts; join the public library; access parks or other public facilities; and receive
7	resident discounts at City golf courses, the zoo and arts institutions. The card could have
8	multiple use options, for example functioning as a public transportation pass, library card,
9	resident golf card, and parking meter card all in one. The cards would also benefit children
10	and youth who become lost and normally possess no identification or emergency contact
11	information and elderly citizens who no longer drive and therefore no longer possess a valid
12	driver's license. Accordingly, it is in the best interests of its residents for the City and County
13	of San Francisco to issue its own municipal identification card.
14	Section 2. The San Francisco Administrative Code is hereby amended by adding
15	Section 95.2, to read as follows:
16	SEC. 95.2. MUNICIPAL IDENTIFICATION CARDS
17	(a) Definitions. For purposes of this Section, the following definitions apply.
18	(1) "Agency" shall mean the Office of the County Clerk.
19	(2) "City" shall mean the City and County of San Francisco, or any department, board,
20	commission or agency thereof.
21	(3) "Director" shall mean the County Clerk.
22	(4) "Entity That Receives City Funds" shall mean any recipient of a contract, grant
23	agreement, or loan agreement from the City and County of San Francisco.
24	

1	(5) "Municipal Identification Card" shall mean an identification card issued by the City
2	and County of San Francisco that shall display, including but not limited to, the cardholder's name,
3	photograph, and date of birth. The card shall not identify the cardholder's gender.
4	(6) "Resident" shall mean a person who can demonstrate that he or she has been presen
5	in the City and County of San Francisco for at least fifteen continuous days and who presents "proof of
6	residency" as specified in subsection $(c)(1)(B)$.
7	(b) Issuance of Municipal Identification Cards. Upon request, the Agency shall issue a
8	Municipal Identification Card to any Resident who meets the application requirements set forth below
9	in subsection (c). The Card shall bear the seal of the City and the Director shall cause the Card to be
10	produced in a form intended to thwart replication or counterfeit.
11	(c) Applications.
12	(1) To obtain a Municipal Identification Card, a Resident shall complete an application
13	requiring proof of identity and proof of residence within the City. Upon receipt of the proof of identity
14	and residency that this Section specifies, the Agency shall issue a Card to the applicant.
15	(A) Proof of Identity. In order to establish identity, each applicant must present
16	<u>either:</u>
17	(i) One of the following documents, except that if the document does not
18	contain the photograph of the applicant, he or she must also present a photo identification: a U.S. or
19	foreign passport; a U. S. driver's license; a US. state identification card; a US. Permanent Resident
20	Card (commonly known as a "Green Card"); a consular identification ("CID") card; a certified copy of
21	a US. or foreign birth certificate; a social security card; or a photo identification card issued by
22	another country to its citizens or nationals that meets the requirements of San Francisco Administrative
23	Code Section 95.1(a). Where the applicant is aged twelve or under he or she need not present photo
24	identification in addition to a birth certificate or social security card; or
25	

1	(ii) Two of the following documents, provided that at least one form of
2	identification shall display the applicant's photograph: a national identification card with photo, name
3	address, date of birth, and expiration date; a foreign driver's license; a US. or foreign voter
4	registration card; a US. or foreign military identification card; a current visa issued by a government
5	agency; a US. Individual Taxpayer Identification Number (ITIN) authorization letter accompanied by
6	an identification with a photograph; an employee identification card, which shall include a union
7	membership card; an identification card issued by a California educational institution, including
8	elementary, middle, secondary, and post-secondary schools.
9	(B) Proof of Residency. In order to establish residency, each applicant must
10	present one of the following items, provided that the item includes both the applicant's name and a
11	residential address located within the City: a utility bill dated within the last thirty days; a rental
12	agreement or rent receipt confirming at least fifteen days of occupancy within the last thirty days; a
13	homeless residency verification form issued by a homeless shelter or an original document issued by a
14	health or social services agency confirming at least fifteen days residency within the last thirty days; a
15	local property tax statement or mortgage payment receipt received within the last ninety days; a bank
16	account statement received within the last ninety days; an employment pay stub issued within the last
17	thirty days; proof of a minor currently enrolled in a City public school; a current San Francisco Golf
18	Resident Card.
19	(2) An application submitted on behalf of a minor must be completed by such minor's
20	parent or legal guardian.
21	(3) The Agency shall keep confidential, to the maximum extent permitted by applicable
22	laws, the name and other identifying information of persons applying for and receiving Municipal
23	Identification Cards.
24	

1	(d) Implementation. The Director is authorized to adopt rules and regulations not inconsistent
2	with this Section in order to implement and administer the issuance of Municipal Identification Cards
3	The Director shall consult with the Immigrant Rights Administrator, under the supervision of the City
4	Administrator, in developing such rules and regulations. The Director may require applicants to
5	declare the information provided in their applications under penalty of perjury. The Immigrant Rights
6	Administrator shall be responsible for coordinating with the Agency and other City Departments the
7	promotion of the Cards and the development of multiple uses for the Cards.
8	(e) Fees. The Director shall charge an application fee of \$15.00 per Card for adults and \$5.00
9	per Card for minors, seniors and low-income adults who present proof of age and/or income status in a
10	form to be determined by the Director. Such fees shall not exceed the administrative costs reasonably
11	associated with the production of the Cards.
12	(f) Acceptance by City Departments and Entities That Receive City Funds. When requiring
13	members of the public to provide identification or proof of residency in the City, each City department
14	and any Entity That Receives City Funds shall accept a Municipal Identification Card as valid
15	identification and as valid proof of residency in the City, unless such City department or Entity has
16	reasonable grounds for determining that the card is counterfeit, altered, or improperly issued to the
17	<u>card holder.</u>
18	Other than requiring the City and Entities That Receive City Funds to accept the Card as proof
19	of identification and City residency, this Section is not intended to replace any other existing
20	requirements for issuance of other forms of identification in connection with the administration of City
21	benefits and services. The requirements of this Section do not apply under circumstances where (1) a
22	federal or State statute, administrative regulation or directive, or court decision requires the City or
23	Entity That Receives City Funds to obtain different identification or proof of residence, (2) a federal or
24	State statute or administrative regulation or directive preempts local regulation of identification or

1	residency requirements, or (3) the City or Entity That Receives City Funds would be unable to comply
2	with a condition imposed by a funding source, which would cause the City or such Entity to lose funds
3	from that source.
4	(g) Operative Date. This ordinance shall become operative nine months after its effective date.
5	(h) City Undertaking Limited to Promotion of General Welfare. In undertaking the
6	enforcement of this ordinance, the City is assuming an undertaking only to promote the general
7	welfare. It is not assuming, nor is it imposing on its officers and employees, an obligation for breach of
8	which it is liable in money damages to any person who claims that such breach proximately caused
9	<u>injury.</u>
10	(i) Severability. In the event that a court or agency of competent jurisdiction holds that federal
11	or state law, rule or regulation invalidates any clause, sentence, paragraph, or section of this Chapter
12	or the application thereof to any person or circumstances, it is the intent of the Board of Supervisors
13	that the court or agency sever such clause, sentence, paragraph, or section so that the remainder of this
14	Chapter shall remain in effect.
