Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings. (a) Pursuant to Public Works Code Section 786, Japanese Cultural and Community Center of Northern California (JCCCNC), requested permission to occupy a portion of the public right-of-way to install a sensu sculpture on the Webster Street median between Geary Boulevard and Post Street, 72' south of the Post Street end of the median, as an iconographic gateway to Japantown neighborhood. The encroachment is a three dimensional free-standing sculpture that consists of an 8' 9 ½" tall replica of a sensu or Japanese folding fan made of powder-coated aluminum supports with decorated porcelain enamel on steel panels forming the fan blades, that is 13' at its widest point and mounted on a 5' 9 ½" powder coated aluminum pedestal base. The encroachment and related construction are shown on plans filed with the Department of Public Works. Copies of such plans are on file with the Clerk of the Board of Supervisors in File No.

| (b) On September 5, 2003, the California Resources Department, the administrator of           |

| funds for the California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal         |
| Protection Act of 2002, awarded a grant of \$333,334 to the JCCCNC to develop and             |
| implement a project preserving and enhancing the significant cultural and historic aspects of |
| San Francisco's Japantown.  |

- (c) San Francisco was the initial point of entry of Japanese immigrants to the United States in the late 1800s and San Francisco's Japantown, established in the Western Addition after the 1906 Earthquake and Fire, is the oldest of only three historic Japantown communities in the United States. Japantown has continued to exist as an active neighborhood community after the unjust forced removal and internment of Japanese Americans during World War II.
- (d) The JCCCNC selected a design team through a competitive design process in 2004, selected the final design plan for the Japantown History Walk in 2005, authorized work to begin on the Japantown History Walk in 2006 and will install the Japantown History Walk elements in 2007.
- (e) The Japantown History Walk is a self-guided tour based on 17 informational signs located throughout the central area of Japantown that will inform visitors, residents, and the general public about the history and culture of Japantown.
- (f) The Japanese folding fan or sensu, as a symbol of beauty, culture, and the interrelationship of Japanese and Japanese American culture, was selected as the icon identifying the Japantown History Walk.
- (g) The Japantown Sensu will serve as a gateway icon for Japantown, will beautify the area by adding a culturally relevant element that depicts both the past and present Japantown.

| 11 | (d) After duly noticed public hearing on, 2007, the Department of                              |
| 12 | Public Works recommended approval of the proposed encroachment as set forth in DPW             |
| 13 | Order No, approved, 2007. A copy of said DPW Order is on file                                  |
| 14 | with the Clerk of the Board of Supervisors in File No, and is incorporated                     |
