3 Resolution extending by 30 days the prescribed time within which the Planning Commission may render its decision on a proposed Ordinance that would amend 4 5 Planning Code Sections 121.2 to move the Polk Street Neighborhood Commercial District from a 3,000 square foot use size limit to a 2,000 square foot size limit, and 6 7 amend Section 723 to provide that commercial and institutional uses in the Polk Street 8 Neighborhood Commercial District are permitted up to 1,999 square feet and allowed 9 as a conditional use for 2,000 square feet and above; and making environmental findings and findings of consistence with the General Plan and priority policies of 10 Planning Code Section 101.1. 11

13 WHEREAS, On June 5, 2007, Supervisor Peskin introduced legislation to initiate the 14 process amending San Francisco Planning Code Sections 121.2 to move the Polk Street Neighborhood Commercial District from a 3,000 square foot use size limit to a 2,000 square 15 16 foot size limit, and amend Section 723 to provide that commercial and institutional uses in the 17 Polk Street Neighborhood Commercial District are permitted up to 1,999 square feet and 18 allowed as a conditional use for 2,000 square feet and above, and making findings, including 19 environmental findings and findings of consistency with the priority policies of Planning Code 20 Section 101.1 and the General Plan. A copy of said legislation is on file with the Clerk of the 21 Board of Supervisors in File No. 070851 and is incorporated herein by reference; and,

22 WHEREAS, On or about June 6, 2007, the Clerk of the Board of Supervisors referred 23 the proposed ordinance to the Planning Commission, which currently is reviewing the 24 proposed ordinance; and,
