8	WHEREAS, A. F. Evans Development, Inc. (the "Project Sponsor") is proposing to
9	construct on the existing University of California extension site bounded by Laguna, Haight,
10	Buchanan and Hermann Streets, seven (7) new buildings and adaptively reuse three (3)
11	existing buildings to create approximately 330 dwelling units, a large institutional residential
12	care facility to accommodate senior residents, approximately 12,000 square feet of community
13	facility space, no more than 4,999 occupied square feet of commercial/retail space,
14	approximately 310 off-street parking spaces, an approximately 25,000 square foot publicly-
15	accessible park on the former Waller Street right-of-way and a community garden of
16	approximately 10,000 square feet; and
17	WHEREAS, the Project Sponsor applied for a project permit and environmental review
18	on August 4, 2004 (City Planning File No. 2004.0773E); and
19	WHEREAS, The Planning Department for the City and County of San Francisco (the
20	"Department") determined that an Environmental Impact Report ("EIR") was required and
21	provided public notice of that determination by publication in a newspaper of general
22	circulation on May 6, 2006; and
23	WHEREAS, On January 27, 2007, the Department published the Draft Environmental
24	Impact Report ("DEIR") for the Project; and

1	WHEREAS, On April 19, 2007, the Commission held a duly noticed public hearing on
2	the DEIR, at which time opportunity for public comment was received on the DEIR, and
3	written comments were received through May 2, 2007; and
4	WHEREAS, The Department prepared responses to comments received at the public
5	hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text
6	of the DEIR and published a Draft Summary of Comments and Responses on November 29,
7	2007; and
8	WHEREAS, A Final Environmental Impact Report ("FEIR") for the Project was
9	prepared by the Department, consisting of the DEIR, any consultations and comments
10	received during the review process, any additional information that became available and the
11	Draft Summary of Comments and Responses, all as required by law; and
12	WHEREAS, On January 17, 2008, the Commission reviewed and considered the FEIR
13	and, by Motion No. 17532, found that the contents of said report and the procedures through
14	which the FEIR was prepared, publicized and reviewed complied with the provisions of the
15	California Environmental Quality Act (CEQA), the State CEQA Guidelines and Chapter 31 of
16	the San Francisco Administrative Code; and
17	WHEREAS, By Motion No. 17532, the Commission found the FEIR to be adequate,
18	accurate and objective, reflected the independent judgment and analysis of the Department
19	and the Commission and that the Summary of Comments and Responses contained no
20	significant revisions to the DEIR, adopted findings relating to significant impacts associated
21	with the Project and certified the completion of the FEIR in compliance with CEQA and the
22	State CEQA Guidelines; and
23	WHEREAS, On January 17, 2008, by Motion Nos. 17533,, 17534 and 17537 and
24	Resolution Nos. 17535 and 17536, the Commission took various approval actions related to
25	the project; and

1	WHEREAS, On February 6, 2008, Cynthia Servetnick, on behalf of Save the Laguna
2	Street Campus, filed an appeal of the FEIR with the Clerk of the Board of Supervisors; and
3	WHEREAS, The Board of Supervisors held a public hearing on March 4, 2008, to
4	review the decision by the Planning Commission to certify the FEIR; and
5	WHEREAS, the FEIR files and all correspondence and other documents have been
6	made available for review by the Board of Supervisors, the Planning Commission and the
7	public; these files are available for public review by appointment at the Planning Department
8	offices at 1650 Mission Street, and are part of the record before the Board of Supervisors; and
9	WHEREAS, this Board has reviewed and considered the FEIR and heard testimony
10	and received public comment regarding the adequacy of the FEIR; now, therefore, be it
11	MOVED, That this Board directs the Clerk of the Board to prepare findings specifying
12	the basis for its disapproval of the certification of the FEIR by the Planning Commission.
