Section 2. The San Francisco Police Code is hereby amended by amending Sections 1060, 1060.1, 1060.2 and 1060.3, to read as follows:

## SEC. 1060. DEFINITIONS.

For the purposes of this Article, *unless otherwise provided in this Article*, the following words and phrases shall mean and include:

- (a) "Any Sidewalk Abutting the Premises." The sidewalk not more than 50 feet from the premises of the Business that is located between the premises and a public street. For purposes of this definition, "premises" includes any immediately adjacent area that is owned, leased, or rented by the permit applicant or Permittee.
- (b) "Bona Fide Nonprofit Club or Organization." Any fraternal, charitable, religious, benevolent, or other nonprofit organization for mutual social, mental, political, or civic welfare, to which admission is limited to members and guests if the revenue accruing therefrom is used exclusively for the benevolent purposes of said organization or agency, and if the organization or agency is exempt from taxation under the Internal Revenue laws of the United States as a bona fide fraternal, charitable, religious, benevolent or nonprofit organization.
- (c) "Business." The enterprise for which a permit is sought or has been issued under this

  Article, whether operated on a for-profit or not-for-profit basis.
- (d) "Conduct that Constitutes a Nuisance." Any conduct that would constitute a violation of the following laws: assault and battery (Cal. Penal Code §240, 242, 245); sexual battery (Cal. Penal Code §243.4); discharging firearm (Cal. Penal Code §246, 246.3); unlawful weapons (Cal. Penal

1	Code §12020; S.F. Police Code §1291); disturbing the peace (Cal. Penal Code § 415, 416, 417);
2	unlawful threats (Cal. Penal Code §422); obstruction of pedestrian or vehicle right of way (Cal. Penal
3	Code § 370); gambling (Cal. Penal Code §§ 330, 337a); rape (Cal. Penal Code §261); statutory
4	rape (Cal. Penal Code §261.5); prostitution and related offenses (Cal. Penal Code §§ 266,
5	<u>266a, 266e, 266h, 266i, 315, 316, 647(b)); sex crimes for which registration is required under the Sex</u>
6	Offender Registration Act (Cal. Penal Code §290); felony sexual assault; loitering for lewd or
7	lascivious purposes (Cal. Penal Code §647(d)); loitering on private property without lawful business
8	(Cal. Penal Code §647(h); identify theft (Cal. Penal Code §530.5); a violent felony warranting
9	enhancement of a prison term (Cal. Penal Code §667.5); criminal gang activity (Cal. Penal Code
10	§186.22); drug offenses (Cal. Health & Safety Code §§ 11351, 11352, 11359, 11360, 11378, 11379,
11	11378.5, 11379.5); violation of Alcohol Beverage Control laws (Cal. Business & Professions Code §§
12	23300, 25602, 25631, 25657, 25658); public urination or defecation (San Francisco Police Code
13	§153); accumulation of filth (Cal. Health & Safety Code § 17920.3(j)); or excessive noise emissions
14	(San Francisco Police Code Section 49 or Article 29).
15	(e) "Corrective Action." Action which includes, but is not limited to, the following:
16	(1) Requesting assistance from the local law enforcement agency in a timely manner
17	regarding the conduct.
18	(2) Requesting those individuals engaging in Conduct that Constitutes a Nuisance to cease
19	the conduct, or ejecting those Persons from the premises.
20	(3) Revising the Security Plan, subject to approval by the Entertainment Commission or the
21	Director as provided under this Article.
22	(f) "Director." The Executive Director of the Entertainment Commission or individual
23	designated by the Director to act on his or her behalf.
24	(g) "Entertainment." Any of the following, except when conducted in a private residence:
25	

1	(1) Any act, play, review, pantomime, scene, song, dance act, song and dance act, or poetry
2	recitation, conducted in or upon any premises to which patrons or members are admitted.
3	(2) The playing or use of any instrument capable of producing or used to produce musical
4	or percussion sounds, including but not limited to, reed, brass, percussion, or string-like instruments,
5	or karaoke, or recorded music presented by a live disc jockey on the premises.
6	(3) A fashion or style show.
7	(4) The act of any female entertainer, while visible to any customer, who exposes the breast
8	or employs any device or covering which is intended to simulate the breast, or wears any type of
9	clothing so that the breast may be observed.
10	(h) "Manager." The individual authorized by the Permittee to exercise discretionary power
11	to organize, direct, carry out or control the operations of the Business.
12	(i) "Permittee." The Person to whom a permit has been issued under this Article.
13	(j) "Person." Any person, individual, firm, partnership, joint venture, association, social
14	club, fraternal organization, joint stock company, corporation, estate, trust, business trust, receiver,
15	trustee, syndicate, or any other group or combination acting as a unit excepting the United States of
16	America, the State of California, and any political subdivision of either.
17	(k) "Place of Entertainment." Every premises to which patrons or members are admitted
18	which serves food, beverages, or food and beverages, including but not limited to alcoholic beverages,
19	for consumption on the premises and wherein Entertainment as defined in Subsection (g) is furnished
20	or occurs upon the premises.
21	(1) "Sale of the Business" or "Sell the Business." The sale or other transfer of the
22	ownership interest in a Business that results in a Person (who did not already have such a percentage
23	interest) owning 50% or more of the Business, regardless of the form of ownership.
24	(m) "Security Guard." A person who has a valid Proprietary Private Security Officer
25	registration document issued by the California Department of Consumer Affairs; or a person who is a

1	Patrol Special Police Officer appointed by the Police Commission or an assistant to a Patrol Special
2	Police Officer and is operating in accordance with rules of the Police Commission governing
3	Patrol Special Police Officers and assistants to Patrol Special Police Officers.
4	(n) "Security Plan." A plan that adequately addresses the safety of persons and property by
5	(i) providing a ratio of one Security Guard to a specific number of individuals as described in
6	the paragraph immediately below at least one Security Guard for every 100 individuals
7	anticipated to be present at any one time during Entertainment events on the premises of the
8	Business, (ii) securing the sidewalk for a 100-foot radius in all directions around the premises of the
9	Business to prevent injury to persons and/or damage to property, and (iii) providing for the orderly
10	dispersal of individuals and traffic from the premises of the Business and within 100 feet of any door
11	that patrons use to enter or exit the premises. The phrase "100 feet" in (iii) of this Subsection (n) means
12	100 feet from the door in both directions on the same side of the street as the premises of the Business.
13	The plan shall include sufficient staff with the requisite experience to implement the plan.
14	The Security Plan must provide at least one Security Guard for every 100 individuals
15	anticipated to be present at any one time during Entertainment events on the premises of the
16	Business, with the following two qualifications. There must always be at least one Security
17	Guard for every 100 indiividuals actually present at any one time during Entertainment events
18	on the premises of the Business. Further, in those areas of the City where a conditional use
19	authorization is required for a late night use, on Fridays from 9:00 p.m. until closing (including
20	early morning hours Saturday) and Saturdays from 9:00 p.m. until closing (including early
21	morning hours Sunday) the Security Plan must provide at least one Security Guard for every
22	100 individuals authorized by the Occupancy Permit during Entertainment events on the
23	premises of the Business,
24	

1	The definition of Security Plan in this subsection 1060(n) does not limit the discretion of
2	the Entertainment Commission and Director as specified in this Article to impose more
3	stringent requirements for a Security Plan as circumstances warrant.
4	(o) "Tax Collector." Tax Collector of the City and County of San Francisco.
5	(p) "Professional Entertainer." A person who is compensated for his or her
6	performance. This definition does not restrict the definition of "Entertainment" in Subsection
7	(g) and is relevant only to the extent the term "professional entertainer" is used.in this Article.
8	(a) "Place of Entertainment." Every premises to which patrons or members are
9	admitted which serves food, beverages, or food and beverages, including but not limited to alcoholic
10	beverages, for consumption on the premises and wherein entertainment as defined in Subsections (b),
11	(c), or (e) is furnished or occurs upon the premises.
12	(b) "Entertainment." Any act, play, review, pantomime, scene, song, dance act, song
13	and dance act, or poetry recitation, conducted or participated in by any professional entertainer in or
14	upon any premises to which patrons or members are admitted.
15	"Entertainment," in addition, is defined to mean and include the playing upon or use by any
16	professional entertainer of any instrument that is capable of or can be used to produce musical sounds
17	or percussion sounds, including but not limited to, reed, brass, percussion or string-like instruments, or
18	recorded music presented by a live disc jockey on the premises.
19	(c) "Entertainment," Continued. "Entertainment" also includes a fashion or style show
20	in which the models are professional entertainers, except when conducted by a bona fide nonprofit club
21	or organization as a part of the social activities of such club or organization, and when conducted
22	solely as a fundraising activity for charitable purposes.
23	(d) "Professional Entertainer." A person who is compensated for his or her
24	performance.

1	(e) "Entertainment," Continued; Exhibition of Human Body. "Entertainment" also
2	includes the act of any female professional entertainer, while visible to any customer, who exposes the
3	breast or employs any device or covering which is intended to simulate the breast, or wears any type of
4	clothing so that the breast may be observed.
5	(f) "Person." Any person, individual, firm, partnership, joint venture, association,
6	social club, fraternal organization, joint stock company, corporation, estate, trust, business trust,
7	receiver, trustee, syndicate or any other group or combination acting as a unit excepting the United
8	States of America, the State of California, and any political subdivision of either thereof.
9	(g) "Operator." Any person operating a place of entertainment in the City and County
10	of San Francisco, including, but not limited to, the owner or proprietor of such premises, lessee,
11	sublessee, mortgagee in possession, permittee or any other person operating such place of
12	entertainment or amusement.
13	(h) "Bona Fide Nonprofit Club or Organization." Any fraternal, charitable, religious
14	or benevolent, or any other nonprofit organization having a regular membership association primarily
15	for mutual social, mental, political and civic welfare, to which admission is limited to members and
16	guests and revenue accruing therefrom shall be used exclusively for the benevolent purposes of said
17	organization and which organization or agency is exempt from taxation under the Internal Revenue
18	laws of the United States as a bona fide fraternal, charitable, religious, benevolent or nonprofit
19	organization.
20	(i) "Admission Charge." Any charge for the right or privilege to enter any place of
21	entertainment including a minimum service charge, a cover charge or a charge made for the use of
22	seats and tables, reserved or otherwise.
23	(j) "Tax Collector." Tax Collector of the City and County of San Francisco.
24	(k) "Security Plan." A plan that (i) provides at least 1 security guard for every 100
25	persons authorized by the Occupancy Permit, (ii) secures a 50 foot perimeter in all directions around

1	the location of the Place of Entertainment to prevent injury to persons and/or damage to property, and
2	(iii) provides for the orderly disbursement of persons and traffic from the Place of Entertainment. The
3	Entertainment Commission, in consultation with the San Francisco Police Department, shall develop
4	rules and regulations implementing this section.
5	SEC. 1060.1. PERMIT REQUIRED.
6	$\underline{(a)}$ It shall be unlawful for any $\underline{Person} \ \underline{person}$ to own, conduct, operate, $\underline{or}$ maintain- $\underline{or}$
7	$to \ participate \ therein$ , or to cause or permit to be conducted, operated, or maintained, any $\underline{Place}$
8	of Entertainment place of entertainment or One Time Event in the City and County of San
9	Francisco without first having obtained $\underline{the\ required}\ a$ permit from the $\underline{Director\ or}$ Entertainment
10	Commission.
11	(b) It shall be unlawful for any Person to conduct, operate or maintain, or cause or permit
12	to be conducted, operated, or maintained, a Place of Entertainment or One Time Event for which a
13	permit has been granted (1) after the permit has been revoked or is otherwise invalid or (2) for any
14	period of time during which the permit has been suspended.
15	(c) It shall be unlawful for any Person who is required to surrender a permit upon the sale
16	of a Business as required under Section 1060.24(b) to fail to do so.
17	(d) Any place or premises where a Place of Entertainment Permit or One Time
18	Event Permit is sought must conform to all existing health, safety, zoning and fire ordinances
19	of the City and County of San Francisco, and must have a valid permit to operate (formally
20	referenced in this Article as a public eating place permit) from the Department of Public
21	Health. The Entertainment Commission, including the Director in the case of a One Time
22	Event Permit, may issue a permit under this Article conditional upon the applicant receiving
23	the other required permits.
24	Any place or premises where a permit to operate is sought must conform to all existing health,
25	safety, zoning and fire ordinances of the City and County of San Francisco, and must have a valid

1	public eating place permit from the Department of Public Health. The Entertainment Commission may
2	issue a permit under this Section conditional upon the applicant receiving the other required permits.
3	Any permit granted by the Entertainment Commission conditional upon the applicant receiving
4	other required permits may be appealed to the Board of Permit Appeals. Such appeal must be filed
5	within ten (10) days of the final decision of the Entertainment Commission issuing the conditional
6	permit.
7	Any conditional permit granted by the Entertainment Commission will expire nine (9) months
8	from the date of the final decision of the Entertainment Commission, if all other required permits have
9	not been received.
10	SEC. 1060.2. FILING <u>APPLICATION, NOTICE TO OTHER CITY DEPARTMENTS,</u>
11	AND DEPARTMENTAL REPORTS.
12	(a) Every <u>Person person</u> <u>seeking</u> <u>desiring</u> a <u>Place of Entertainment</u> permit <u>or an</u>
13	amendment to a permit pursuant to this Article shall file an application with the Entertainment
14	Commission upon a form provided by the Entertainment Commission and shall pay a filing fee
15	as provided in Section 2.26 of this Code.
16	(b) The Director shall send the application to the San Francisco Police Department, Fire
17	Department, Department of Building Inspection, Department of Public Health, and Planning
18	Department. Those departments shall complete all necessary inspections and report their
19	determinations to the Entertainment Commission within 20 City business days of receiving the
20	application.
21	SEC. 1060.3. APPLICATION FORM.
22	Operators under any permit issued pursuant to this Article shall be limited to the terms of the
23	application. Except as otherwise provided herein, an application for a permit pursuant to the
24	provisions of this Article shall specify the following and be signed under penalty of perjury:
25	(a) The name and street address of the Business for which the permit is sought.

1	(b) The name and address of the applicant as follows:
2	(1) If the applicant is a corporation, the name of the corporation exactly as shown in its
3	articles of incorporation; the date and place of incorporation; and the name and address of each
4	officer and director.
5	(2) If the applicant is a Person other than a publicly traded company, the name and
6	address of every Person that directly or indirectly owns or controls 10% or more of the assets,
7	ownership interests or voting interests in that Person.
8	(c) The name of and contact information for the Manager who shall directly, or through
9	designees, be on the premises during all hours of operation.
10	(d) The name and address of each Person who appears on the business registration
11	certificate for the Business for which a permit is sought.
12	(e) The name and address of each Person to whom the Department of Alcoholic Beverage
13	Control has issued a license for the Business for which a permit is sought.
14	(f) The names and addresses of the Persons who have or will have authority or control over
15	the Business and a brief statement of the nature and extent of such authority and control, if the
16	applicant has not otherwise provided this information in the application.
17	(g) The name and address of the Person authorized to accept service of process.
18	(h) A plan for the Business to operate as a Place of Entertainment, specifying the days
19	and hours of operation, the number of employees and their duties, the number of patrons, a statement
20	certifying that the Business shall comply with the maximum occupancy load for the space as established
21	under the San Francisco Building and Fire Codes, the types or classes of entertainment (in terms
22	of the types of instruments, numbers of performers, and sound levels) to be provided, and the
23	amount of parking, both on and off-site, to be provided. If sound amplification is to be used, the plan
24	shall also include a specific description of the amplification system.
25	(i) A proposed Security Plan as defined in Section 1060(n).

1	(j) For the Persons(s) whose disclosure is required under Subsections (b), (c), (e) and (f),
2	all criminal charges, complaints or indictments in the preceding five ten years which resulted in a
3	conviction or a plea of guilty or no contest for the following laws: assault and battery (Cal. Penal Code
4	§240, 242, 245); felony sexual assault; sexual battery (Cal. Penal Code §243.4); rape (Cal. Penal
5	Code §261); statutory rape (Cal. Penal Code §261.5); discharging firearm (Cal. Penal Code
6	§246, 246.3); unlawful weapons (Cal. Penal Code §12020; S.F. Police Code §1291); disturbing the
7	peace (Cal. Penal Code § 415, 416, 417); unlawful threats (Cal. Penal Code §422); obstruction of
8	pedestrian or vehicle right of way (Cal. Penal Code § 370); gambling (Cal. Penal Code §§ 330, 337a);
9	prostitution and related offenses (Cal. Penal Code §§266, 266a, 266e, 266h, 266i, 315, 316,
10	647(b)); sex crimes for which registration is required under the Sex Offender Registration Act (Cal.
11	Penal Code §290); loitering for lewd or lascivious purposes (Cal. Penal Code §§ 647(d), 647(h));
12	identify theft (Cal. Penal Code §530.5); a violent felony warranting enhancement of a prison term
13	(Cal. Penal Code §667.5); criminal gang activity (Cal. Penal Code §186.22); drug offenses (Cal.
14	Health & Safety Code §§ 11351, 11352, 11359, 11360, 11378, 11379, 11378.5, 11379.5); violation of
15	Alcohol Beverage Control laws (Cal. Business & Professions Code §§ 23300, 25602, 25631, 25657,
16	25658); or for conduct in another jurisdiction which if carried out in California would constitute an
17	offense under one of the laws set forth in this Subsection (j).
18	(k) All criminal charges, complaints or indictments in the preceding five ten years which
19	resulted in a conviction for the Person(s) whose disclosure is required under Subsections (b), (c), (e)
20	and (f), for any other offense which is a felony or misdemeanor under the laws of this state, or for
21	conduct in another jurisdiction which if carried out in California would constitute a felony or
22	misdemeanor under the laws of this state, provided that this Subsection (k) applies only to offenses
23	arising out of the operation of a nightclub, dance hall, cabaret, Place of Entertainment or an
24	establishment that serves food or beverages.

1	(l) For the information required by Subsections (j) and (k), a statement setting forth for
2	each Person all charges under which convictions or pleas of guilty or no contest were obtained, any
3	sentence imposed, and for each matter the date, name and location of the court; and if the Person
4	was granted parole or probation, whether the Person successfully completed parole or
5	probation.
6	(m) Such further information as the Entertainment Commission requires regarding financial
7	and lease arrangements and management, authority, and operational control of the Business or its
8	premises when the information will assist the Commission in its determination whether to grant or deny
9	the permit.
10	(a) The address of the location for which the permit is required, together with the business
11	name of such location.
12	(b) The name and proposed business address of the applicant. If the applicant is a corporation
13	the name of the corporation shall be set forth exactly as shown in its articles of incorporation; and the
14	applicant shall also set forth the date and place of incorporation; the names and residence addresses of
15	each of the officers, directors, and each stockholder owning more than 10 percent of the stock of the
16	corporation. If the applicant is a partnership, the application shall set forth the name and residence
17	address of each of the partners, including limited partners. If one or more of the partners is a
18	corporation, the provisions of this Section pertaining to a corporate applicant apply.
19	(c) Whether or not the applicant or any officer or director or member of applicant, as the case
20	may be, has ever been convicted of any crime except misdemeanor traffic violations. In addition to the
21	foregoing, any corporate applicant shall state whether or not any stockholder owning more than 10

4	which the permit is requested and a brief statement of the nature and extent of such authority and

6	(e) Such information pertinent to the operation of the proposed activity, including information
7	as to management, authority control, financial agreements, and lease arrangements, that is reasonably
8	related to the factual determinations this ordinance empowers the Entertainment Commission to make
9	in reviewing and acting upon permit applications as the Entertainment Commission may require of an
10	applicant in addition to the other requirements of this Section. The foregoing examples are in
11	explanation of and not in limitation of the information which the Entertainment Commission may
12	<del>require.</del>
13	(f) A business plan for the proposed place of entertainment, specifying the days and hours of
14	operation, the number of patrons, the numbers of employees and their duties, the identity of the
15	manager or managers who shall be on premises during all hours of operation, the types or classes of
16	entertainment (in terms of the types of instruments, numbers of performers and sound levels) to be
17	provided, and the amount of parking, both on site and off site, to be provided. If sound amplification is
18	to be used, the plan shall also include a specific description of the amplification system.
19	(g) The address to which notice, when required, is to be sent or mailed, and the name and
20	address of a person authorized to accept service of process, if not otherwise set forth herein.
21	(h) Whether the application is for a new permit or for the renewal of an existing permit.
22	(i) The Entertainment Commission may require further information as it deems necessary.

3	(2) In the event of a continued hearing, the applicant shall cause notice of the continued
4	hearing to be conspicuously and continuously posted on the premises of the Business for at least 10
5	days before the date of the continued hearing. The Director shall provide notice of the hearing
6	electronically or by mail at least 10 days before the hearing to any Person who has filed a written
7	request for such notice
8	(3) The failure of the Director to provide the notice of the hearing to any Person who filed a
9	written request as provided in Subsections (b)(1) and (2) of this Section shall not constitute grounds for

18	documented authorization from the department that issued the citation.
19	(6) If the Chief of Police or the Chief's designee, in person at the Entertainment
20	Commission hearing on the permit application or in writing prior to the hearing, objects to the
21	granting of the permit on the basis that the Commission should make one or more of the
22	findings stated in subsections (f)(1)-(4) above, the Commission may not issue the permit
23	without specifically addressing the objection in writing or on the record, at a Commission
24	meeting, and explaining specifically why the objection does not warrant the finding. This

5	(i) When considering whether to grant a permit application or to suspend or revoke
6	a permit under this Article, the Commission and the Director may consider any previous denia

9	the previous action are relevant to the current determination.
10	(a) When an application is filed for a new permit under this Article, the Entertainment

6	25657, 25658; Health and Safety Code Sections 11351, 11352, 11359, 11360, 11378, 11379, 11378.5,
7	11379.5; or, the proprietor or persons in charge thereof have implemented, maintained or permitted
8	any admission or related policy or practice which violates Section 3305 of the San Francisco Police
9	Code.
10	(4) The proprietor or persons in charge thereof have violated or permitted the violation of
11	any other provision of this Article or of the permit, on the premises or in connection with the operation
12	of the establishment.
13	(b) The penalty for the first violation under Subsection (a) within a period of six months
14	shall be suspension of said permit for a period of 30 days. The penalty for the second violation within a
15	period of six months shall be suspension of said permit for a period of 60 days. The penalty for the thire
16	and subsequent violations within a period of six months shall be suspension of said permit for a period
17	of 90 days. For the purposes of this Subsection, calculation of the six months shall not include any
18	period of time during which the permit was suspended.
19	(c) Any permit issued under the terms of this Article may be revoked at any time by the

21	premises of the Business, or in connection with the operation of the Business, that would constitute a
22	violation of any of the following laws: assault and battery (Cal. Penal Code §§240, 242, 245); sexual
23	battery (Cal. Penal Code §243.4); discharging firearm (Cal. Penal Code §§246, 246.3); unlawful
24	weapons (Cal. Penal Code §12020; S.F. Police Code §1291); disturbing the peace (Cal. Penal Code
25	§§415, 416, 417); unlawful threats (Cal. Penal Code §422); obstruction of pedestrian or vehicle right

1	of way (Cal. Penal Code §370); gambling (Cal. Penal Code §§330, 337a); rape (Cal. Penal Code
2	§261); statutory rape (Cal. Penal Code §261.5); prostitution and related offenses (Cal. Penal
3	Code §§266, 266a, 266e, 266h, 266i, 315, 316, 647(b)); sex crimes for which registration is required
4	under the Sex Offender Registration Act (Cal. Penal Code §290); felony sexual assault; loitering for
5	lewd or lascivious purposes (Cal. Penal Code §647(d)); loitering on private property without lawful
6	business (Cal. Penal Code §647(h)); identify theft (Cal. Penal Code §530.5); a violent felony

11	Francisco Police Code §153); accumulation of filth (Cal. Health & Safety Code §17920.3(j)); or
12	excessive noise emissions (San Francisco Police Code Section 49 or Article 29); or
13	(ii) The Permittee has failed to take reasonable steps within the Permittee's control upon th
14	request of the Police Department, the Entertainment Commission or the Director to halt conduct on the
15	premises of the Business, or in connection with the operation of the Business, that would constitute a
16	violation of the laws set forth in Section (a)(3)(i) of this Section; or
17	(iii) The Permittee in the operation of the Business has implemented, maintained, or
18	permitted an admission or related policy or practice prohibited by San Francisco Police Code Section
19	3305 (prohibiting discrimination); or
20	(4) The Permittee or any employee or agent of the Permittee has violated any requirement
21	of this Article or any other applicable ordinance, any regulation adopted pursuant to this Article, or
22	any condition placed on the permit; or
23	(5) The Permittee has failed to submit a proposed Security Plan as required by Section
24	1060.31; or

1	(6) The Permittee or any agent or employee of the Permittee has failed to comply with an
2	approved Security Plan as required by Section 1060.31 or a revised Security Plan as required by
3	<u>Section 1060.32; or</u>
4	(7) The Permittee or any agent or employee of the Permittee has failed to request
5	emergency medical services as required by Section 1060.20(b).
6	(b) HEARING PROCEDURE AND DETERMINATION.
7	(i) The Entertainment Commission shall give the Permittee and the Manager written notice
8	of a hearing to determine whether to suspend a permit. The notice shall set forth the grounds for the
9	proposed suspension and the date, time and location of the hearing.
10	(ii) The Chief of Police or the Chief's designee may request in writing that the
11	Director bring a suspension proceeding before the Entertainment Commission. If, within 10
12	business days of receiving the request, the Director has not brought the suspension
13	proceeding, the Chief may bring the suspension proceeding before the Entertainment
14	Commission. In such a case, the Chief or the Chief's representative shall present the case for
15	suspension, except that the Director may join in presenting the case for suspension if the
16	Director agrees to do so.
17	(c) PERIOD OF SUSPENSION. The Entertainment Commission may suspend a permit for
18	the periods of time set forth in this Subsection (c).
19	(i) For the first violation under Subsection (a)(1) through (6) of this Section, for up to 30
20	<u>days.</u>
21	(ii) For the second violation of the same or any other provision of Subsection (a)(1) through
22	(6) within six months of the order of suspension for the first violation, for up to 60 days.
23	(iii) For the third and subsequent violation of the same or any other provision of Subsection
24	(a)(1) through (6) within six months of the order of suspension for the second or any subsequent
25	violation, for up to 90 days.

1	(iv) For the purpose of Subsections (c)(ii) and (iii) of this Section, calculation of the six
2	months shall not include any period of time during which the permit was suspended.
3	(v) In determining the length of the suspension, the Entertainment Commission shall
4	consider the seriousness and the frequency of the violation(s) in light of the effort taken to correct then
5	and the impact of the violation(s) on the surrounding neighborhood.
6	SEC. 1060.20.2. LIMITED SUSPENSION BY THE DIRECTOR; APPEAL TO
7	ENTERTAINMENT COMMISSION.
8	(a) GROUNDS FOR SUSPENSION. The Director may suspend any permit issued under
9	this Article for a period of up to seven days if the Director determines, after providing the Permittee
10	and the Manager at least five days written notice and an opportunity to respond, that any of the
11	<u>circumstances set forth in either Subsections (a)(1),(2), or <math>(2)</math>(3) of this Section has occurred. Each</u>
12	order of limited suspension may include multiple violations under Subsections (a)(1), (2), or and (2)
13	(3) of this Section. The Director shall provide the written notice required under this Subsection either
14	by mail and electronically or by personal delivery.
15	(1) The Business has exceeded the allowable noise emissions under Section 49 or Article 29
16	of the San Francisco Police Code, or as required under any condition imposed on the permit, on three
17	separate days within a three month time period. The Director may suspend a permit under this
18	Subsection (a)(1) only if:
19	(i) The San Francisco Police Department, the Director, or an authorized agent of either
20	has issued a noise emission report for each violation showing noise levels that exceed those allowed
21	under Section 49 or Article 29 of the San Francisco Police Code, or as required under any condition
22	imposed on the permit, and
23	(ii) The Director has provided notice of the issuance of each noise emission report to the
24	Permittee or the Manager electronically or by mail within three City business days of its issuance.
25	

1	(2) The Permittee or any employee or agent of the Permittee has engaged in Conduct that
2	Constitutes a Nuisance or the Permittee has failed to take reasonable steps within the Permittee's
3	control to halt another Person from engaging in Conduct that Constitutes a Nuisance. "Conduct that
4	Constitutes a Nuisance" as defined in Section 1060(d), means any conduct that would constitute a
5	violation of the following laws: assault and battery (Cal. Penal Code §240, 242, 245); sexual battery
6	(Cal. Penal Code §243.4); discharging firearm (Cal. Penal Code §246, 246.3); unlawful weapons (Cal.
7	Penal Code §12020; S.F. Police Code §1291); disturbing the peace (Cal. Penal Code § 415, 416, 417).
8	unlawful threats (Cal. Penal Code §422); obstruction of pedestrian or vehicle right of way (Cal. Penal
9	Code § 370); gambling (Cal. Penal Code §§ 330, 337a); rape (Cal. Penal Code §261); statutory
10	rape (Cal. Penal Code §261.5); prostitution and related offenses (Cal. Penal Code §§ 266, 266a
11	266e, 266h, 266i, 315, 316, 647(b)); sex crimes for which registration is required under the Sex
12	Offender Registration Act (Cal. Penal Code §290); felony sexual assault; loitering for lewd or
13	lascivious purposes (Cal. Penal Code §647(d)); loitering on private property without lawful business
14	(Cal. Penal Code §647(h)); identify theft (Cal. Penal Code §530.5); a violent felony warranting
15	enhancement of a prison term (Cal. Penal Code §667.5); criminal gang activity (Cal. Penal Code
16	§186.22); drug offenses (Cal. Health & Safety Code §§ 11351, 11352, 11359, 11360, 11378, 11379,
17	11378.5, 11379.5); violation of Alcohol Beverage Control laws (Cal. Business & Professions Code §§
18	23300, 25602, 25631, 25657, 25658); public urination or defecation (San Francisco Police Code
19	§153); accumulation of filth (Cal. Health & Safety Code § 17920.3(j)); or excessive noise emissions
20	(San Francisco Police Code Section 49 or Article 29).
21	This Subsection (a)(2) applies only when both of the following apply:
22	(i) The conduct occurred on the premises of, or on Any Sidewalk Abutting the Premises of,
23	the Business, and
24	

1	(ii) The conduct continued after the Director had notified the Permittee of the problem and
2	informed the Permittee of Corrective Action, as defined in Section 1060, to address the problem, but the
3	Permittee failed to take the Corrective Action.
4	(3) The Permittee or any agent or employee of the Permittee has failed to comply
5	with an approved Security Plan as required by Section 1060.31 or a revised Security Plan as
6	required by Section 1060.32.
7	(b)(1) ISSUANCE OF ORDER; RIGHT TO APPEAL TO COMMISSION. On the day that the
8	Director issues an order of limited suspension, the Director shall send the order to the Permittee and
9	Manager by mail or electronically. The order shall state the date that the order issued and the date
10	that it takes effect. To provide the Permittee with an opportunity to file an appeal to the Entertainment
11	Commission, an order of limited suspension shall not take effect for at least five City business days
12	from the date that the Director issues the order.
13	(2) A Permittee may appeal an order of limited suspension to the Entertainment
14	Commission by filing with the Commission Secretary a written request for review within five City
15	business days of the date that the Director has issued the order. The filing of an appeal stays the order
16	pending the Commission's decision. If a Permittee withdraws the appeal, the Director's order shall no
17	longer be stayed and shall take effect on the date of the withdrawal or the date that the order was to
18	take effect, whichever is later.
19	(3) The Commission may affirm, overturn, or modify the Director's order. When the
20	Commission affirms or modifies the Director's order, the order takes effect the day following the day of
21	the hearing at which the Commission made its determination.
22	(4) If the Permittee does not file a timely appeal of the Director's order, the order shall take
23	effect the day after the time to appeal has expired or the effective date set forth in the order, whichever
24	is later; provided, however, that the Director and the Permittee may agree in writing to an earlier
25	effective date.

1	(5) The Entertainment Commission may adopt a regulation establishing a procedure which
2	would allow the Director or the Commission, or both, to stay and vacate an order of limited suspension
3	if the Permittee submits and complies with a plan to address the problems that gave rise to the
4	suspension.
5	(c) The Director may initiate orders of limited suspension under this Section against
6	a Permittee for a Business at a single location no more than three times in any twelve-month
7	period. The Director shall initiate suspension proceedings before the Commission under
8	Section 1060.20.1 against any Business that is suspended by the Director under this Section
9	three times in any twelve-month period. For purposes of this Subsection (d), "suspended by
10	the Director" includes a suspension affirmed in whole or part or modified by the Commission if
11	appealed pursuant to Subsection (b)(2) but does not include a suspension overturned by the
12	Commission on appeal. This Subsection (d) shall not in any way preclude the Commission
13	from otherwise exercising its authority to suspend a Business under Section 1060.20.1, or
14	preclude the Director or Chief of Police or Chief's designee from initiating a suspension
15	proceeding under Section 1060.20.1.
16	(d) POLICE DEPARTMENT RECOMMENDATION OF LIMITED SUSPENSION BY
17	THE DIRECTOR. The Chief of Police, or the Chief's designee, may recommend to the
18	Director, orally or in writing, that the Director suspend a permit in accordance with the grounds
19	for suspension stated in subsection (a) above. If the recommendation is oral, it shall later be
20	reduced to writing and filed with the Director when time permits. If the Director fails to follow
21	the oral or written recommendation, the Director shall report to the Entertainment Commission
22	both the recommendation and the reason or reasons for not following the recommendation.
23	This report shall occur at the next regular Commission meeting subsequent to the
24	recommendation, consistent with the provisions of the Brown Act and Sunshine Ordinance.
25	For purposes of this subsection (d), the Captain for the district where the Place of
	Mayor, Supervisor Maxwell

Entertainment is located, or the Captain's designee, is deemed the Chief's designee unless
the Chief of Police directs otherwise.
This subsection (d) shall not preclude any police officer from recommending to the
Director that the Director suspend a permit in accordance with the grounds for suspension
stated in subsection (a) above.
SEC. 1060.20.3. SUSPENSION FOR PUBLIC SAFETY BY THE DIRECTOR.
(a) GROUNDS FOR SUSPENSION. The Director may suspend any permit issued under
this Article for up to 72 hours if the Director determines, after providing the Permittee at least 8 hours
written notice and an opportunity to respond, that any of the circumstances set forth in Subsection
(a)(1)(i) or (ii) of this Section has occurred either on the Premises of the Business, or on Any
Sidewalk Abutting the Premises of the Business, or within 100 feet of the Premises of, the Business,
provided in this last instance that the person engaging in the conduct that would constitute a
violation of a law specified in Subsection (a)(1)(i) had been on the Premises of the Business
no more than 30 minutes before engaging in that conduct; that such the conduct has resulted or
could have resulted in serious bodily injury or death; and that continued operation of the Business
poses a serious threat to public safety.
(1)(i) The Permittee or any employee or agent of the Permittee has engaged in conduct that
would constitute a violation of any of the following laws: assault and battery (Cal. Penal Code §§240,
242, 245); felony sexual assault; sexual battery (Cal. Penal Code §243.4); rape (Cal. Penal Code
§261); statutory rape (Cal. Penal Code §261.5); pimping (Cal. Penal Code §266); discharging
firearm (Cal. Penal Code §§246, 246.3); unlawful weapon (Cal. Penal Code §12020; S.F. Police Code
§1291); disturbing the peace (Cal. Penal Code §§ 415, 416, 417); unlawful threats (Cal. Penal Code
§422); a violent felony warranting enhancement of a prison term (Cal. Penal Code §667.5); criminal
gang activity (Cal. Penal Code §186.22); or

1	(ii) The Permittee has failed to take reasonable steps within the Permittee's control and
2	within the limits of the law to halt the conduct of another Person that would constitute a violation of
3	any law described in Subsection (a)(1)(i) of this Section.
4	(b) NOTICE OF PROPOSED ORDER. The Director shall provide the written notice
5	required under Subsection (a) of this Section to the Permittee and the Manager by personal delivery
6	and electronically.
7	(c) EFFECTIVE DATE AND TIME OF ORDER. The order of suspension for public safety
8	issued under this Section shall take effect at the date and time stated in the order.
9	(d) DIRECTOR MAY VACATE ORDER. The Director may vacate an order of suspension
10	for public safety if the Director determines that operation of the Business before expiration of the
11	suspension order will not pose a danger to the public because additional information demonstrates that
12	the conduct was not related to the operation of the Business, the Permittee has taken adequate steps to
13	correct the problem giving rise to the suspension, or other circumstances warrant such action.
14	(e) POLICE DEPARTMENT RECOMMENDATION OF SUSPENSION FOR PUBLIC
15	SAFETY. The Chief of Police, or the Chief's designee, may recommend to the Director, orally
16	or in writing, that the Director suspend a permit for public safety in accordance with the
17	grounds for suspension stated in subsection (a) above. If the recommendation is oral, it shall
18	later be reduced to writing and filed with the Director when time permits. If the Director fails to
19	follow the oral or written recommendation, the Director shall report to the Entertainment
20	Commission both the recommendation and the reason or reasons for not following the
21	recommendation. This report shall occur at the next regular Commission meeting subsequent
22	to the recommendation, consistent with the provisions of the Brown Act and Sunshine
23	Ordinance. For purposes of this subsection (e), the Captain for the district where the Place of
24	Entertainment is located, or the Captain's designee, is deemed the Chief's designee unless
25	the Chief of Police directs otherwise.

1	This subsection (e) shall not preclude any police officer from recommending to the
2	Director that the Director suspend a permit for public safety in accordance with the grounds
3	for suspension stated in subsection (a) above.
4	SEC. 1060.20.4. REVOCATION OF A PERMIT.
5	(a) GROUNDS FOR REVOCATION. The Entertainment Commission may revoke any
6	Place of Entertainment or One Time Event Permit issued under this Article if it determines after a
7	public hearing that any of the following conditions exist:
8	(1) The Permittee has knowingly made any false, misleading, or fraudulent statement of
9	material fact or has knowingly omitted a material fact in the application for a permit; or
10	(2) The Permittee has failed to pay any fee or charge required under this Article; or
11	(3) The Permittee has failed to surrender the permit as required by Section
12	<u>1060.24(b).</u>
13	(b) HEARING BY COMMISSION. The Entertainment Commission shall give the Permittee
14	and the Manager written notice of a hearing to determine whether to revoke a permit. The notice shall
15	set forth the grounds for the proposed revocation and the date, time and location of the hearing.
16	(c) APPLICATION FOR PERMIT AFTER REVOCATION. The revocation of a permit
17	under this Article shall not preclude the Permittee from applying for a new permit under this Article.
18	(d) When considering whether to grant a permit application or to suspend or revoke a
19	permit under this Article, the Commission and the Director may shall consider any previous denial of
20	a permit application or previous suspension or revocation of a permit, under this Article or Article
21	15.2, for the same permit applicant or Permittee when the circumstances warranting the previous
22	action are relevant to the current determination.
23	Section 8. The San Francisco Police Code is hereby amended by repealing Section
24	1060.22:
25	SEC. 1060.22. LICENSE FEES.

1	Every permittee who conducts, permits or assists in conducting or permitting any entertainment
2	as defined in Sections 1060 (b) and (c) to be shown, staged, exhibited, or produced in or upon any
3	permitted premise shall pay to the Tax Collector an annual license fee, payable in advance.
4	The license fee prescribed in this Section is due and payable on a calendar year basis starting
5	120 days after the effective date of this Article, prorated with regard to the calendar year on a monthly
6	basis. Fees for new licenses issued after the first day of January, 1971, or in any subsequent calendar
7	year shall be prorated with regard to the calendar year on a monthly basis.
8	Section 9. The San Francisco Police Code is hereby amended by amending Section
9	1060.24, to read as follows:
10	SEC. 1060.24. PLACE OF ENTERTAINMENT PERMITS NOT TRANSFERABLE;
11	PERMIT MUST BE SURRENDERED UPON SALE OF BUSINESS; PERMIT AMENDMENT
12	REQUIRED TO CHANGE PARTNERS OR OTHER OWNERS TRANSFER OF PERMIT.
13	(a) No Person may transfer a Place of Entertainment Permit issued under this Article to an
14	other Person.
15	(b) If a Place of Entertainment Permittee Sells the Business, the Permittee shall promptly
16	surrender the permit to the Director. If the Permittee fails to surrender the permit to the Director, the
17	Director may, after giving the Permittee notice by mail and electronically of the proposed action and
18	an opportunity to respond, revoke the permit.
19	(c) Notwithstanding Subsections (a) and (b) of this Section, a Permittee may change
20	partners, shareholders, or other owners of a Business provided that (1) the sale or other transfer of
21	ownership results in a Person owning no more than 50% of the Business, regardless of the form of
22	ownership, and (2) the Permittee obtains an amendment to the Permit as provided in this Section. If
23	the transfer of ownership does not result in any Person (who did not already have such a percentage
24	interest) having an ownership interest of ten percent or more, the Permittee is not required to obtain a
25	permit amendment.

1	(d) A Permittee seeking to amend a permit as required under this Section shall pay the filing
2	fee for Permit Amendment/Additional Partner set forth in Section 2.26 of this Code. The applicant
3	shall provide that portion of the information sought under Section 1060.3 for an application that the
4	Director requires.
5	(e) The Director shall determine within 30 days of the filing of a complete application to
6	amend a permit whether to approve it. The Director shall approve the application unless he or she
7	determines that denial is warranted under any of the grounds set forth in Section 1060.5(f) and shall
8	notify the Permittee and Manager of the approval electronically and either by mail or personal
9	<u>delivery.</u>
10	(f) If the Director determines that disapproval of the application may be warranted under
11	Section 1060.5(f), the Director shall schedule a hearing on the matter for the next regularly scheduled
12	meeting of the Entertainment Commission. The Director shall promptly provide written notice of the
13	hearing to the Permittee and the Manager by mail and electronically.
14	(g) The Entertainment Commission shall determine whether to approve the application
15	according to the standards governing the initial application set forth in Section 1060.5(f).
16	No permit shall be transferable except with the written consent of the Entertainment
17	Commission. An application for such a transfer shall be in writing and shall be accompanied by the
18	same filing fee as for an initial application. The written application for such transfer shall contain the
19	same information as requested herein for an initial application for such a permit.
20	Section 10. The San Francisco Police Code is hereby amended by adding Sections
21	1060.24.1 and 1060.24.2, to read as follows:
22	SEC. 1060.24.1. COMPLIANCE WITH CONDITIONS; AMENDMENT OF PERMIT TO
23	CHANGE CONDITIONS.
24	No Permittee shall operate a Business in any manner inconsistent with any condition imposed
25	on the permit. A Permittee may request an amendment to a permit to remove or change a condition by

1	filing a request with the Secretary of the Commission and paying the fee for an Amendment to a Permit
2	required under Police Code Section 2.26. The Entertainment Commission shall conduct a hearing and
3	determine whether to approve the application to amend the permit according to the procedures
4	governing the initial application as set forth in Section 1060.5 and the standards set forth in Section
5	<u>1060.5(f).</u>
6	SEC. 1060.24.2. APPEALS TO THE BOARD OF APPEALS.
7	(a) The following actions taken under this Article may be appealed to the Board of Appeals.
8	The granting or denial of a permit, including a conditionally granted permit, or an amendment to a
9	permit, and the suspension or revocation of a permit. Any such appeal shall be filed within ten days
10	from the date of the decision, as provided in Section 8 of the San Francisco Business and Tax
11	Regulations Code.
12	(b) Notwithstanding the provisions of Subsection (a) of this Section, the Permittee or permit
13	applicant may seek immediate judicial review of the actions described in Subsection (a) of this Section
14	pursuant to California Code of Civil Procedure Section 1085 or Section 1094.8, as these provisions
15	may be amended, including any successor provisions, or any other procedure provided by law; the
16	Permittee or permit applicant is not required to exhaust his or her administrative remedies before the
17	Entertainment Commission or before the Board of Appeals.
18	Section 11. The San Francisco Police Code is hereby amended by amending Sections
19	1060.25 and 1060.29, to read as follows:
20	SEC. 1060.25. <u>CRIMINAL AND ADMINISTRATIVE PENALTIES PENALTY.</u>
21	(a) CRIMINAL PENALTY. Any person who violates any provision any provisions of
22	this Article Section 1060.1 of this Article (requiring a valid permit to operate) shall be deemed
23	guilty of an infraction. Any person who violates this Article more than once in a 12-month
24	period shall be guilty of an infraction or a misdemeanor, at the discretion of the prosecutor. A
25	first violation of this Article is an infraction is punishable by a fine of not more than \$100. A

1	second violation within one year of the date of the first violation is an infraction punishable by
2	a fine of not more than \$200 or a misdemeanor punishable by a fine of not to exceed \$1,000 or by
3	imprisonment in the County Jail for a period not to exceed six months, or by both such fine and
4	imprisonmen, at the discretion of the prosecutor. A third or subsequent violation within one
5	year of the date of the second or subsequent violation is an infraction punishable by a fine of
6	not more than \$500 or a misdemeanor punishable by a fine of not to exceed \$1,000 or by
7	imprisonment in the County Jail for a period not to exceed six months, or by both such fine
8	and imprisonment, at the discretion of the prosecutor. Each day a Person conducts, operates, or
9	maintains a Business without a valid permit shall constitute a separate violationan infraction. Any
10	person who violates this Article more than once in a 12 month period shall be guilty of an infraction or
11	a misdemeanor, at the discretion of the prosecutor. A violation which is an infraction is punishable by e
12	fine of not more than \$100. A violation which is a misdemeanor is punishable by a fine not to exceed
13	\$1000 or by imprisonment in the County Jail for a period not to exceed six months, or by both such fine
14	and imprisonment.

## (b) ADMINISTRATIVE PENALTY.

(1)The Director may issue administrative citations for the violation of any condition imposed on a permit granted under this Article and any violation of Section 1060.31 or 1060.32 (governing Security Plans). San Francisco Administrative Code Chapter 100, "Procedures Governing the Imposition of Administrative Fines," is hereby incorporated in its entirety and shall govern the amount of fees and the procedure for imposition, enforcement, collection, and administrative review of administrative citations issued under this Subsection (b). The Director shall impose fines for violations of any permit condition and any violation of Section 1060.31 or 1060.32 as set forth in Section 100.5(a) of the San Francisco Administrative Code.

(2) Notwithstanding Subsection (b)(1) of this Section, the procedure governing the appeal of a citation set forth in San Francisco Administrative Code Chapter 100 is revised as provided in this

1	Subsection (b)(2). The Controller may designate the Director of the Department of Public Works as a
2	hearing officer under San Francisco Administrative Code Section 100.7, but shall designate such
3	officer for no more than one appeal a month and for no more than 12 times in a 12-month period.
4	Additionally, any violation of the provisions of this Article Section 3305 of Article 33 by a
5	permittee hereunder shall be deemed cause to or to revoke or suspend a permit pursuant to Secs.
6	1060.20 and/or 1060.23 of this Article.
7	SEC. 1060.29. ONE <u>TIME</u> <u>NIGHT</u> EVENT PERMIT.
8	(a) This Section provides a procedure for permitting a Person to conduct, maintain,
9	promote or sponsor Entertainment on the premises specified in the One Time Event Permit for a limited
10	number of one-day occurrences in a 12-month period, including operation between 2:00 a.m. and 6:00
11	a.m. No Person shall conduct, maintain, promote or sponsor Entertainment between 2:00 a.m. and
12	6:00 a.m. without a One Time Event Permit or an Extended-Hours Premises Permit. One Time Event
13	Permits may be issued for a premises for which a Place of Entertainment Permit has been issued, but
14	for which no Extended-Hours Premises Permit has been issued, when the applicant proposes operating
15	between 2:00 a.m. and 6:00 a.m. Nevertheless, the One Time Event Permit is not intended to
16	function as a routine substitute for a Person's securing either the Place of Entertainment
17	Permit or the Extended-Hours Permit when the Person's course of conduct indicates that
18	either or both of those permits would be more appropriate to seek. For purposes of One Time
19	Event Permits, the word "premises" means the area or structure where the event for which a permit is
20	sought occurs.
21	(b) Except as otherwise provided in this Section, the Director may issue One Time Event
22	Permits and applicants may appeal the Director's denial of an application to the Entertainment
23	Commission.
24	(c) Each One Time Event Permit shall issue for no longer than one 24-hour period. One
25	Time Event Permits may not be issued for the same premises for consecutive 24-hour periods

1	without a six-hour break between the end time for the first permit and the start time for the
2	second permit. If a One Time Event Permit includes permission to operate between 2:00 and
3	6:00 a.m., another One Time Event Permit for the same premises later that calendar day may
4	not authorize commencement of operations before 12:00 noon.
5	(d) There shall be no limit on the number of One Time Event Permits a Person may obtain,
6	provided that no more than one permit per month is issued for the same premises. Notwithstanding this
7	restriction, the Director may grant One Time Event Permits may be issued for events that will
8	occur on consecutive days on the same premises or on non-consecutive days within a ten-day period on
9	the same premises, but shall not issue permits allowing events to occur for more than 12 days on the
10	same premises within any twelve-month period.
11	(e) A Person may obtain more than one One Time Event Permit for the same day.
12	In such an instance, in considering whether to grant the permit(s) and/or place conditions on
13	the permit(s), the Director or Entertainment Commission as appropriate under the procedures
14	of this Section, shall give heightened scrutiny to each permit application to ensure that the
15	legal standards for granting the permit(s) are met and to determine what conditions, if any,
16	may be appropriate to place on the permit(s). In addition, if the applicant submits an
17	application for more than one One Time Event Permits for the same day less than 40 days

4	information required for applications under Section 1060.5 as the Director may require. For events
5	taking place in an outdoor area or in both a structure and an outdoor area, the Security Plan
6	shall include additional security personnel to provide adequate security, as determined by the

24	standards set forth in Section 1060.5(f) and shall grant a permit unless the Director finds that the
25	application was filed less than seven days before the proposed event, denial is warranted under any of

17	(f) An applicant whose application for a permit has been denied pursuant to this Section may		
18	appeal to the Board of Permit Appeals. The applicant is required to exhaust his or her administrative		
19	remedies before the Board of Appeals.		
20	Section 12. The San Francisco Police Code is hereby amended by adding Section		
21	1060.29.1, to read as follows:		
22	SEC. 1060.29.1. SPECIAL PERMIT PROCEDURE FOR ONE TIME EVENTS FOR		
23	DESIGNATED DAYS.		
24	(a) The City has experienced difficulties meeting its basic duty to provide police, fire and		
25	emergency medical services (all "essential services") throughout the City on those occasions such as		

1	New Year's Eve, Halloween and the 4th of July where multiple simultaneous or overlapping events			
2	attract large crowds. The Board of Supervisors finds that the adoption of a special permit procedure			
3	for the review and processing of applications for One Time Events permits for these occasions will help			
4	ensure sufficient essential services to protect the safety of all residents of and visitors to the City, while			
5	accommodating special events to the extent consistent with the City's basic public safety obligations.			
6	By authorizing the adoption of a special permit procedure, the Board intends to encourage applicants			
7	to apply for One Time Events Permits sufficiently in advance of the event to enable the City to plan for			
8	the provision of essential services. Applicants who apply later may have to bear the additional cost of			
9	increased security that the City could have avoided with more advance notice. In addition, the Board			
10	authorizing the Commission to place reasonable limits on the number of One Time Event Permits			
11	issued on these designated days to the extent that the Commission determines necessary to ensure			
12	public safety.			
13	(b) The Entertainment Commission may adopt a special permit procedure for One Time			
14	Events occurring on those designated days for which the Commission finds a substantial risk that the			
15	approval of multiple, simultaneous or overlapping One Time Events would (i) require the diversion of			
16	so great a number of police officers to police the events as to prevent adequate police protection to the			
17	rest of the City or (ii) result in a concentration of persons and vehicles that would unduly interfere with			
18	the proper delivery of essential services in the City. In making this determination, the Commission			
19	shall consider the need for the delivery of essential services both on the day of the event and until 6:00			
20	a.m. the next day.			
21	(c) If the Entertainment Commission elects to adopt a special permit procedure under this			
22	Section, it shall first consult with the San Francisco Police Department.			
23	(d) This Section empowers the Entertainment Commission to designate no more than 12			
24	days in a calendar year when the special permit procedure shall apply to applications for One Time			
25	Event Permits.			

1	(e) The Commission must adopt the procedure for each calendar year no later than
2	November 1 of the preceding year. The Commission may adopt a procedure for multiple calendar
3	years, in which case it may amend the procedure so long as it acts no later than November 1 preceding
4	January 1 of the year to which the amended procedure applies.
5	(f) The provisions of this Section supplement those set forth in Section 1060.29. Under the
6	special permit procedure authorized under this Section, the following additional provisions apply:

18	(B) Disapprove the application on the ground that the applicant filed too late to give the
19	City adequate time to plan for the provision of essential services for the day of the event without
20	compromising the safety and security of the rest of the City where alternative conditions cannot
21	sufficiently mitigate the public safety and security problems that the event poses.
22	(3) The Commission may disapprove an application for a One Time Event Permit for events
23	proposed for one of the days designated under this Section, irrespective of the date of the filing, where
24	(i) the conduct of the event, when considered in light of all other events occurring on the day of the
25	event, will require the diversion of so great a number of police officers to properly police the event as

1	to impair the capacity of the City to provide adequate police protection to the rest of the City and (ii)			
2	the Commission is unable to fashion conditions with which the applicant must comply that will address			
3	the public safety and security problems that the event poses. In considering whether to disapprove			
4	an application, the Commission may consider the number, size, and geographic concentration			
5	of proposed One-Time Events for the designated day. For purposes of this Subsection (f)(3), the			
6	"day of the event" includes until 6:00 a.m. after the designated day.			
7	(g) The special permit procedure may limit the number of permits issued for the designated			
8	days when the Commission finds a substantial risk that approval of all applications for One Time			
9	Events for that day would (i) require the diversion of so great a number of police officers to properly			
10	police all the events as to prevent adequate police protection to the rest of the City and (ii) the			
11	Commission is unable to fashion conditions with which the applicant must comply that will address the			
12	public safety and security problems that the event poses. In considering whether to limit the			
13	number of permits issued for a designated day, the Commission may consider the number,			
14	size, and geographic concentration of proposed One-Time Events for the designated day. If			
15	the Commission limits the number of permits, the Commission may authorize approval of applications			
16	on a first-come first-served basis, selection by lottery, or other method that is objective and fair and			
17	unrelated to the content of the Entertainment provided. In addition, the Commission may include a			
18	schedule of limits that vary depending on the size and location as they affect congestion that could			
19	impede prompt delivery of essential services.			
20	(h) The authority to impose conditions on days designated by the Commission under this			
21	Section includes the authority to require Permittees to comply with the conditions both on the			
22	designated day and until 6:00 a.m. the next day.			
23	(i) The Commission shall provide at least 10 days notice of the hearing to adopt or amend			
24	the special permit procedure. The Commission may provide notice electronically to Businesses then

20	(c) Every Place of Entertainment Permittee that does not have a Security Plan approved by			
21	the Entertainment Commission on the effective date of this Section shall submit a proposed Security			
22	Plan to the Director.			
23	(1) The Director shall mail notice of the requirements of this Section to each Permittee that			
24	does not have a Security Plan approved by the Entertainment Commission on the effective date of this			
25	Section.			

1	(2) Each Permittee shall submit a proposed plan no later than 30 days from the date of the			
2	Director's notice. Upon receiving a proposed plan, the Director shall send a copy to the San Francisco			
3	Police Department, which shall have 10 City business days to review and make recommendations to the

5	(3) The Director shall review each proposed plan and, after reviewing any			
6	recommendations submitted by the San Francisco Police Department, shall approve or disapprove it.			
7	When disapproving a proposed plan, the Director shall notify the Permittee what changes are required			
8	to obtain approval.			
9	(4) If the Director disapproves the plan submitted by the Permittee, the Permittee may			
10	appeal the Director's determination to the Entertainment Commission by submitting a written appeal to			
11	the Secretary of the Commission within ten days of the Director's disapproval. Upon receiving an			
12	appeal, the Commission shall promptly notify the San Francisco Police Department. When acting on			
13	an appeal, the Commission may approve, overturn or modify the Director's determination. If the			
14	Commission overturns the Director's order, the Permittee shall comply with the Security Plan as			
15	submitted to the Director under Subsection (c). If the Commission modifies the order, it shall set forth			
16	any changes to the plan that the Permittee shall be required to make and the Permittee shall comply

19	Director's disapproval of the proposed plan, the Permittee shall comply with the Security Plan that

22	Subsection (c)(1) of this Section to gain approval of the Security Plan from the Director or the

1	(d) The Entertainment Commission may suspend a Place of Entertainment permit as set
2	forth in Section 1060.20.1(a)(5) if the Permittee has failed to submit a proposed Security Plan.
3	(e) The Commission may suspend a Place of Entertainment permit as set forth in Sections
4	$\underline{1060.20.1(a)(5)}$ and $\underline{1060.20.1(a)(6)}$ for failure to comply with the plan as required under this Article.
5	(f) The suspension of a permit for violation of this Section may be appealed to the Board of
6	Appeals as provided in Section 1060.24.2.
7	(g) For the purpose of calculating compliance with the component of a Security Plan
8	that requires a ratio of one Security Guard to a specific number of individuals, a Security
9	Guard may be counted toward the ratio for only one Place of Entertainment at any one time.
10	This calculation rule applies whether the required ratio of Security Guard to individuals is
11	based solely on the definition of Security Plan in Section 1060(n), is otherwise required by this
12	Article, or is a condition of the Place of Entertainment permit.

- (h) An exemption from paying the full fee specified in Subsections (a), (b), (c), (d), (e), (f), and (g) herein may be granted upon the filing under penalty of perjury of a declaration of indigency on the form provided and approved by the Board. All agencies of the City and County of San Francisco are exempted from these fees.

Notice of appeal shall be in such form as may be provided by the rules of the Board of Appeals.

On the filing of any appeal, the Board of Appeals shall notify in writing the department, board, commission, officer or other person from whose action the appeal is taken of such appeal. On the filing of any appeal concerning a structural addition to an existing building, the Board of Appeals shall additionally notify in writing the property owners of buildings immediately adjacent to the subject building.

The Board of Appeals shall fix the time and place of hearing, which shall be not less than 10 nor more than 45 days after the filing of said appeal, and shall act thereon not later than 60 days after such filing or a reasonable time thereafter. In the case of a fixed pedestal newsrack permit, a place of entertainment permit or an extended-hours premises permit, the Board of Appeals shall set the hearing not less than 15 days after the filing of said appeal.

shall act thereon not more than 30 days after such filing, and shall not entertain a motion for rehearing. With respect to any decision of the Board of Appeals related to any "dwelling" in which "protected class members" are likely to reside (each as defined in Administrative Code Chapter 87), the Board of Appeals shall comply with the requirements of Administrative Code Chapter 87 which requires, among other things, that the Board of Appeals not base any decision regarding the development of such units on information which may be discriminatory to any member of a "protected class." Pending decision by the Board of Appeals, the action of such department, board, commission, officer or other person from which an appeal is taken shall be suspended, except for excluding (1) actions of revocation or suspension of permit by the Director of Public Health when determined by the Director to be an extreme public health hazard and (2) actions by the Zoning Administrator or Director of the Department of Building Inspection stopping work under or suspending an issued permit, and (3) actions of suspension or revocation by the Entertainment Commission or the Director of the Entertainment Commission of a Place of Entertainment, One Time Event, or Extended-Hours Premises permit when the suspending or revoking authority determines that ongoing operation of the activity during the appeal to the Board of Appeals would pose a serious threat to public safety shall be suspended.

## SEC. 26. FACTS TO BE CONSIDERED BY DEPARTMENTS.

- (a) Subject to Subsection (b) below, in the granting or denying of any permit, or the revoking or the refusing to revoke any permit, the granting or revoking power may take into consideration the effect of the proposed business or calling upon surrounding property and upon its residents, and inhabitants thereof; and in granting or denying said permit, or revoking or refusing to revoke a permit, may exercise its sound discretion as to whether said permit should be granted, transferred, denied or revoked.
- (b) In the granting or denying of any permit, or the revoking or the refusing to revoke any permit with respect to a "dwelling" in which "protected class members" are likely to reside

1	(each as defined in Administrative Code Chapter 87), the granting or revoking power shall
2	comply with the requirements of San Francisco Administrative Code Chapter 87 which
3	requires, among other things, that the granting or revoking power not base any decision

- (c) A department authorized to issue or transfer permits shall not issue or transfer a permit to any person who does not have a current business tax registration certificate when such person is required to obtain a business tax registration certificate pursuant to Section 1003 of Part III of the San Francisco Municipal Code.
- (d) Notwithstanding Subsection (a) of this Section, the provisions of Article 15.1

  (Entertainment Regulations Permit and License Provisions) and Article 15.2 (Entertainment

  Regulations for Extended-Hours Premises) of the Police Code shall govern actions taken on the granting, denial, amendment, suspension and revocation of permits regulated under those Articles, not the standards set forth in Subsection (a).

Section 15. FINDINGS <u>AND PURPOSE</u>. In adopting this Ordinance and Ordinance No. \_\_\_\_\_\_, the Board of Supervisors is mindful of public safety problems that sometimes are presented by the operation of businesses that provide entertainment for which the Commission issues a permit under the Police Code. At the most extreme, there have been serious violent incidents such as shootings, stabbings, and physical altercations occurring on the premises of such businesses, or in the immediate vicinity arising from or related to activities conducted on the premises. In such circumstances, the safety of patrons, employees, neighbors, passers-by, and police officers must be of paramount concern to the City. In addition, there are less extreme but nonetheless serious problems that sometimes are presented by the operation of these businesses, relating to noise and other criminal

1	conduct that is in itself harmful to the public and that can ultimately lead to serious public
2	safety concerns. This Ordinance and Ordinance No provide reasonable and
3	narrowly drawn options for the City to protect public safety without unduly interfering with the
4	operation of businesses holding a permit Issued by the Entertainment Commission.
5	The general purpose of this Ordinance and Ordinance No. is to
6	strengthen the ability of the Entertainment Commission, working in concert with other City
7	bodies, including the Police Department, to address public safety issues arising in the
8	entertainment industry, by revising the standards and processes for the granting and
9	suspension of permits. The purpose is not to relax or weaken standards for the granting of
10	Place of Entertainment, One Time Event, or Extended-Hours Premises permits. Revisions in
11	terminology are intended to clarify existing outdated or unclear language and/or to update the
12	ordinances with language that better reflects existing practices.
13	Section 16. SEVERABILITY. If any section, subsection, subdivision, paragraph,
14	sentence, clause or phrase of this Ordinance or of Article 15.1 of the Police Code, or any part
15	thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of
16	competent jurisdiction, such decision shall not affect the validity or effectiveness of the
17	remaining portions of this Ordinance or of Article 15.1, Code or any part thereof. The Board or
18	Supervisors hereby declares that it would have passed each section, subsection, subdivision,
19	paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more
20	sections, subsections, subdivision paragraphs, sentences, clauses or phrases be declared
21	unconstitutional or invalid or ineffective.
22	Section 17. In undertaking the enforcement of this ordinance, the City is assuming an
23	undertaking only to promote the general welfare. It is not assuming, nor is it imposing on its

officers and employees, an obligation for breach of which it is liable in money damages to any

person who claims that such breach proximately caused injury.
