13	Be it ordained by the People of the City and County of San Francisco:					
14	Section 1. The San Francisco Police Code is hereby amended by amending Sections					
15	1070, 1070.1, 1070.2, and 1070.3, to read as follows:					
16	SEC. 1070. DEFINITIONS.					
17	For the purpose of this Article, unless otherwise provided in this Article, the following					
18	words and phrases shall mean and include:					
19	(a) "Any Sidewalk Abutting the Premises." The sidewalk not more than 50 feet from the					
20	premises of the Business that is located between the premises and a public street. For purposes of this					
21	definition, "premises" includes any immediately adjacent area that is owned, leased, or rented by the					
22	permit applicant or Permittee.					
23	(b) "Bona Fide Nonprofit Club or Organization." Any fraternal, charitable, religious,					
24	benevolent, or other nonprofit organization for mutual social, mental, political, or civic welfare, to					
25	Mayor, Supervisor Maxwell BOARD OF SUPERVISORS Page 1					

1 which admission is limited to members and guests if the revenue accruing therefrom is used exclusively 2 for the benevolent purposes of said organization or agency, and if the organization or agency is exempt 3 from taxation under the Internal Revenue laws of the United States as a bona fide fraternal, charitable, 4 religious, benevolent or nonprofit organization. "Bona Fide Public Eating Place." A place which is regularly and in a bona fide 5 (c)6 manner used and kept open for the serving of meals to quests for compensation, with and which 7 has suitable kitchen facilities connected therewith, containing conveniences for cooking an assortment of foods which may be required for ordinary meals-, the kitchen of which must be kept 8 9 in a sanitary condition with the proper amount of refrigeration for keeping of food on said premises and must comply with all the regulations of the Department of Public Health. "Meals" 10 means the usual assortment of foods commonly ordered at various hours of the day; the 11 12 service of such food and victuals only as sandwiches or salads shall not be deemed a compliance with this requirement. "Guests" shall mean persons who, during the hours when 13 meals are regularly served therein, come to a bona fide public eating place for the purpose of 14 obtaining, and actually order and obtain at such time, in good faith, a meal therein. Nothing in 15 this Section, however, shall be construed to require that any food be sold or purchased with 16 17 any beverage. 18 "Business." The enterprise for which a permit is sought or has been issued under this (d)19 Article, whether operated on a for-profit or not-for-profit basis. 20 (*e*) "Conduct that Constitutes a Nuisance." Any conduct that would constitute a violation of the following laws: assault and battery (Cal. Penal Code §240, 242, 245); sexual battery (Cal. Penal 21 22 Code §243.4); discharging firearm (Cal. Penal Code §246, 246.3); unlawful weapons (Cal. Penal 23 Code §12020; S.F. Police Code §1291); disturbing the peace (Cal. Penal Code § 415, 416, 417); unlawful threats (Cal. Penal Code §422); obstruction of pedestrian or vehicle right of way (Cal. Penal 24 Code § 370); gambling (Cal. Penal Code §§ 330, 337a); rape (Cal. Penal Code §261); statutory 25

- 12 (f) "Corrective Action." Action which includes, but is not limited to, the following:
- 13 (1) Requesting assistance from the local law enforcement agency in a timely manner
- 14 <u>regarding the conduct.</u>
- 15 (2) Requesting those individuals engaging in Conduct that Constitutes a Nuisance to cease
- 16 *the conduct, or ejecting those Persons from the premises.*
- 17 (3) Revising the Security Plan, subject to approval by the Entertainment Commission or the
- 18 *Director as provided under this Article.*
- 19 (g) "Dance Academy." The term "Extended-Hours Premises" also includes a dance
- 20 *academy wherein students are admitted between 2:00 a.m. and 6:00 a.m., and instruction is given in*
- 21 *ballroom or other types of dancing, whether to the students in groups or individually.*
- 22 (h) "Director." The Executive Director of the Entertainment Commission or an individual
- 23 <u>designated by the Director to act on his or her behalf.</u>
- 24 (*i*) "Entertainment." Any of the following, except when conducted in a private residence:
- 25

1	(1) Any act, play, review, pantomime, scene, song, dance act, song and dance act, or poetry
2	recitation, conducted in or upon any premises to which patrons or members are admitted.
3	(2) The playing or use of any instrument capable of producing or used to produce musical
4	or percussion sounds, including but not limited to, reed, brass, percussion, or string-like instruments,
5	or karaoke, or recorded music presented by a live disc jockey on the premises.
6	(3) A fashion or style show.
7	(4) The act of any female professional entertainer, while visible to any customer, who
8	exposes the breast or employs any device or covering which is intended to simulate the breast, or wears
9	any type of clothing so that the breast may be observed.
10	(j) "Extended-Hours Premises." Every premises to which patrons or members are admitted
11	or which allows patrons or members to remain between 2:00 a.m. and 6:00 a.m. which serves food,
12	beverages, or food and beverages, including but not limited to, alcoholic beverages, for consumption
13	on the premises or wherein Entertainment as defined in Subsection (i) is furnished or occurs upon the
14	premises. The term includes a "Dance Academy."
15	(k) "Manager. The individual authorized by the Permittee to exercise discretionary power
16	to organize, direct, carry out or control the operations of the Business.
17	(1) "Permittee." The person to whom a permit has been issued under this Article.
18	(m) "Person." Any person, individual, firm, partnership, joint venture, association, social
19	club, fraternal organization, joint stock company, corporation, estate, trust, business trust, receiver,
20	syndicate, or any other group or combination acting as a unit excepting the United States of America,
21	the State of California, and any political subdivision of either.
22	(n) "Security Guard." A person who has a valid Proprietary Private Security Officer
23	registration document issued by the California Department of Consumer Affairs; or a person who is a
24	Patrol Special Police Officer appointed by the Police Commission or an assistant to a Patrol Special
25	

1 <u>Police Officer and is operating in accordance with rules of the Police Commission governing</u>

- 2 Patrol Special Police Officers and assistants to Patrol Special Police Officers.
- 3 "Security Plan." A plan that adequately addresses the safety of persons and property by (o)(i) providing a ratio of one Security Guard to a specific number of individuals as described in 4 5 the paragraph immediately below at least one Security Guard for every 100 individuals 6 anticipated to be present at any one time during Entertainment events on the premises of the 7 Business, (ii) securing the sidewalk for a 100-foot radius in all directions around the premises of the 8 Business to prevent injury to persons and/or damage to property, and (iii) providing for the orderly 9 dispersal of individuals and traffic from the premises of the Business and within 100 feet of any door that patrons use to enter or exit the premises. The phrase "100 feet" in (iii) of this Subsection (o) 10 means 100 feet from the door in both directions on the same side of the street as the premises of the 11 12 Business. The plan shall include sufficient staff with the requisite experience to implement the plan. 13 The Security Plan must provide at least one Security Guard for every 100 individuals anticipated to be present at any one time during Entertainment events on the premises of the 14 Business, with the following two gualifications. There must always be at least one Security 15 Guard for every 100 individuals actually present at any one time during Entertainment events 16 on the premises of the Business. Further, in those areas of the City where a conditional use 17 18 authorization is required for a late night use, on Fridays Thursdays, Fridays, Saturdays, and Sundays from 9:00 p.m. until closing (including early morning hours Saturday Friday, 19 Saturday, Sunday, and Monday) and Saturdays from 9:00 p.m. until closing (including early 20 21 morning hours Sunday) the Security Plan must provide at least one Security Guard for every 100 individuals authorized by the Occupancy Permit during Entertainment events on the 22 23 premises of the Business,

1	The definition of Security Plan in this subsection 1060(o) does not limit the discretion of
2	the Entertainment Commission and Director as specified in this Article to impose more
3	stringent requirements for a Security Plan as circumstances warrant.
4	(p) "Tax Collector." Tax Collector of the City and County of San Francisco.
5	(q) "Professional Entertainer." A person who is compensated for his or her
6	performance. This definition does not restrict the definition of "Entertainment" in Subsection
7	(i) and is relevant only to the extent the term "professional entertainer" is used in this Article.
8	(a) Extended-Hours Premises. Every premises to which patrons or members are admitted or
9	which allows patrons or members to remain on the premises between the hours of 2:00 a.m. and 6:00
10	a.m. which serves food, beverages, or food and beverages, including but not limited to, alcoholic
11	beverages, for consumption on the premises or wherein entertainment as defined in Subsections (b) and
12	(c) is furnished or occurs upon the premises.
13	(1) Dance Academies. An extended-hours premises shall also include a dance academy
14	wherein students are admitted between the hours of 2:00 a.m. and 6:00 a.m., and instruction is given in
15	ballroom or other types of dancing, whether given to the students in groups or individually.
16	(b) Entertainment. Any act, play, review, pantomime, scene, song, dance act, song and dance
17	act, or poetry recitation, conducted or participated in by any professional entertainer in or upon any
18	premises to which patrons or members are admitted. "Entertainment" also includes a fashion or style
19	show, except when conducted by a bona fide nonprofit club or organization as part of the social
20	activities of such club or organization, and when conducted solely as a fund-raising activity for
21	charitable purposes. (The term "professional entertainer" as used herein means a person or persons
22	who engage in the presentation of entertainment for livelihood or gain.)
23	"Entertainment," in addition, is defined to mean and include the playing upon or use of any
24	instrument that is capable of or can be used to produce musical sounds or percussion sounds, including
25	but not limited to, reed, brass, percussion or string-like instruments; provided, further, that
	Mayor Supervisor Maxwell

- 1 *"entertainment" is defined to mean any instrument or device capable of producing or reproducing*
- 2 *sound, which device is located in a premises open between the hours of 2:00 a.m. and 6:00 a.m.*
- 3 (c) Informal Entertainment. Any act, play, review, pantomime, scene, song, dance act, song
 4 and dance act, or poetry recitation, conducted or participated in by any nonprofessional person or
- 5 *persons in or upon any premises to which patrons or members are admitted.*
- 6 (d) Person. An individual, firm, partnership, joint venture, association, social club, fraternal
- 7 organization, joint stock company, corporation, estate, trust, business trust, receiver, syndicate, or any
- 8 *other group or combination acting as a unit excepting the United States of America, the State of*
- 9 *California, and any political subdivision of either thereof.*
- 10 (e) Operator. Any person operating an extended-hours premises in the City and County of San
- 11 *Francisco, including, but not limited to, the owner or proprietor of such premises, lessee, sublessee,*
- 12 *mortgagee in possession, licensee or any other person operating such place of entertainment or*
- 13 *amusement*.
- 14 (f) Bona Fide Nonprofit Club or Organization. Any fraternal, charitable, religious or benevolent, or any other nonprofit organization having a regular membership association primarily for 15 16 mutual social, mental, political and civil welfare, to which admission is limited to members and guests 17 and revenue accruing therefrom to be used exclusively for the benevolent purpose of said organization 18 and which organization or agency is exempt from taxation under the Internal Revenue laws of the 19 United States as a bona fide fraternal, charitable, religious, benevolent or nonprofit organization. 20 (g) Admission Charge. Any charge for the right or privilege to enter any extended-hours 21 premises including a minimum service charge, a cover charge or a charge made for the use of seats 22 and tables, reserved and otherwise. 23 (h) Tax Collector. Tax Collector of the City and County of San Francisco. 24 (i) "Bona Fide Public Eating Place." A place which is regularly and in bona fide manner used and kept open for the serving of meals to guests for compensation and which has suitable kitchen 25

1	facilities connected therewith, containing conveniences for cooking an assortment of foods which may
2	be required for ordinary meals, the kitchen of which must be kept in a sanitary condition with the

11	SEC. 1070.1. PERMIT REQUIRED.
12	(a) It shall be unlawful for any Person to own, conduct, operate, maintain, or to cause or
13	permit to be conducted, operated, or maintained, an Extended-Hours Premises in the City and County
14	of San Francisco without first having obtained a permit from the Entertainment Commission.
15	(b) It shall be unlawful for any Person to own, conduct, operate or maintain, or cause or
16	permit to be conducted, operated, or maintained, an Extended-Hours Premises for which a permit has
17	been granted (1) after the permit has been revoked or is otherwise invalid or (2) for any period of time
18	during which the permit has been suspended.
19	(c) It shall be unlawful for any Person who is required to surrender a permit upon the sale
20	of a Business as required under Section 1070.22 to fail to do so.
21	(d) Any place or premises where an Extended-Hours Premises Permit is sought
22	must conform to all existing health, safety, zoning, and fire ordinances of the City and County
23	of San Francisco, and must have a valid permit to operate (formerly referenced in this Article
24	as a public eating place permit) from the Department of Public Health. The Entertainment
25	

1	Commission may issue a permit under this Article conditional upon the applicant receiving the
2	other required permits.
3	It shall be unlawful for any person to own, conduct, operate, maintain or to participate therein,
4	or to cause or permit to be conducted, operated or maintained, any extended-hours premises in the City
5	and County of San Francisco without first having obtained a permit from the Entertainment
6	Commission.
7	Any place or premises where a permit to operate is sought must conform to all existing health,
8	safety, and fire ordinances of the City and County of San Francisco, and must have a valid public
9	eating place permit from the Department of Public Health The Entertainment Commission may issue
10	a permit under this Section conditional upon the applicant receiving the other required permits.
11	Any permit granted by the Entertainment Commission conditional upon the applicant receiving
12	other required permits may be appealed to the Board of Appeals. Such appeal must be filed within 10
13	days of the final decision of the Entertainment Commission issuing the conditional permit.
14	Any conditional permit granted by the Entertainment Commission will expire nine months from
15	the date of the final decision of the Entertainment Commission, if all the other required permits have
16	not been received.
17	SEC. 1070.2. FILING APPLICATION, NOTICE TO OTHER CITY DEPARTMENTS,
18	AND DEPARTMENTAL REPORTS.
19	Every person <u>seeking desiring</u> a permit <u>or an amendment to a permit under pursuant to this</u>
20	Article shall file an application with the Entertainment Commission upon a form provided by
21	the Entertainment Commission and shall pay a filing fee as provided by Section 2.26 of this Code.
22	(b) The Director shall send the application to the San Francisco Police Department, Fire
23	Department, Department of Building Inspection, Department of Public Health, and Planning
24	Department. Those departments shall complete all necessary inspections and report their
25

SEC. 1070.3. APPLICATION FORM.

- 4 *Operators under any permit issued pursuant to this Article shall be limited to the terms of the*
- 5 *application*. Except as otherwise provided herein, an application for a permit *for a Business*
- 6 pursuant to the provisions of this Article shall specify *for that Business the same information*

7 <u>required under Section 1060.3 of this Code for applications for Place of Entertainment Permits and the</u>

8 *applicant shall sign the application under penalty of perjury.*

- 9 (a) The address of the location for which the permit is required, together with the business name
 10 of such location.
- 11 (b) The name and proposed business address of the applicant. If the applicant is a
- 12 *corporation, the name of the corporation shall be set forth exactly as shown in its articles of*
- 13 *incorporation; and the applicant shall also set forth the date and place of incorporation; the names and*
- 14 *residence addresses of each of the officers, directors, and each stockholder owning more than 10*
- 15 *percent of the stock of the corporation. If the applicant is a partnership, the application shall set forth*
- 16 *the name and residence address of each of the partners, including limited partners. If one or more of*
- 17 *the partners is a corporation, the provisions of this Section pertaining to a corporate applicant apply.*

18 *(c) Whether or not the applicant or any officer or director or member of applicant, as the case*

- 19 *may be, has ever been convicted of any crime except misdemeanor traffic violations. In addition to the*
- 20 *foregoing, any corporate applicant shall state whether or not any stockholder owning more than 10*
- 21 *percent of the stock of such corporation has ever been convicted of any crime except misdemeanor*
- 22 traffic violations. If any person mentioned in this subsection has been so convicted, a statement must be
- 23 *made giving the name of the person so convicted, the place and court in which the conviction was had,*
- 24 *the specific charge under which the conviction was obtained, and the sentence imposed as the result of*
- 25 said conviction.

1 (d) The names and addresses of the persons who have authority or control over the place for 2 which the permit is requested, and brief statement of the nature and extent of such authority and 3 control. (e) Such information pertinent to the operation of the proposed activity, including information 4 5 as to management, authority, control, financial agreements, and lease arrangements, that is reasonably 6 related to the factual determinations this ordinance empowers the Chief to make in reviewing and 7 acting upon permit applications as the Chief of Police may require of an applicant in addition to the 8 other requirements of this Section. The foregoing examples are in explanation and not in limitation of 9 the information which the Entertainment Commission may require. 10 (f) A business plan for the proposed extended-hours premises, specifying the days and hours of operation, the number of patrons, the numbers of employees and their duties, the identity of the 11 12 manager or managers who shall be on premises during all hours of operation, the types or classes of 13 entertainment (in terms of the types of instruments, numbers of performers and sound levels) to be provided, and the amount of parking, both on-site and off-site, to be provided. If sound amplification is 14 15 to be used, the plan shall also include a specific description of the amplification system. 16 (g) The address to which notice, when required, is to be sent or mailed, and the name and 17 address of a person authorized to accept service of process, if not otherwise set forth herein. 18 (h) Whether the application is for a new permit or for the renewal of an existing permit. 19 (i) The Entertainment Commission may require further information as he or she deems 20 necessary. 21 Section 2. The San Francisco Police Code is hereby amended by repealing Section 22 1070.4. 23 SEC. 1070.4. VERIFICATION OF APPLICATION. 24 Every application for a permit under this Article shall be verified as provided in the California 25 *Code of Civil Procedure for the verification of pleadings.* Mayor, Supervisor Maxwell

3	SEC. 1070.4. NOTICE REQUIREMENTS AND CONTACT INFORMATION.
4	(a) Unless otherwise provided in this Article, the following definitions apply.
5	(i) To provide notice "electronically" means to send written notice by email, facsimile or in
6	any other manner that the Director designates as appropriate to transmit written information other
7	than by mail or personal delivery.
8	(ii) To "mail" notice or give notice "by mail" means depositing the notice in a sealed
9	envelope or package, clearly labeled to identify the individual to whom it is sent, in a post office,
10	mailbox, or other facility regularly maintained by the United States Postal Service, by First Class Mail,
11	with postage prepaid. The requirement that notice be mailed within a specified period of time means
12	that the notice is deposited in the mail within that period of time.
13	(iii) "Personally deliver" or "personal delivery" means delivering notice or causing notice to
14	be delivered in person.
15	(iv) "Notice" means notice of a hearing, decision, action required of an applicant for a
16	permit or a Permittee, or any other information that this Article requires to be given or which the
17	Entertainment Commission or the Director find appropriate in implementing the provisions of this
18	<u>Article.</u>
19	(b) Applicants for a permit and Permittees shall provide information necessary to enable
20	the Entertainment Commission and the Director to give notice under this Article. Applicants and
21	Permittees shall provide the Director in writing with a street address where the applicant and
22	Permittee receive mail from the United States Postal Service, and with any email address, facsimile
23	number or other information necessary to enable notice to be sent to the applicant and Permittee
24	electronically. The applicant and Permittee shall keep the information required by this Section current
25	by informing the Director in writing of any change. When the Commission or Director mails or

- 2 with the information most recently provided in writing by that Person, such action shall satisfy the

- 5 *provide a telephone and/or cell phone number and a facsimile number or email address for the*
- 6 <u>transmission of notice to the Manager</u>. The Permittee shall keep current the contact information for the
- 7 <u>Manager and shall notify the Director in writing of any change in this information</u>. The Manager may
- 8 *designate other individuals to whom notice is to be given for any periods of the Manager's absence or*
- 9 <u>unavailability by providing this information in writing to the Director. When the Commission or</u>
- 10 *Director mails or personally delivers notice or sends notice electronically to the Manager, or to any*
- 11 *individual designated by the Manager to receive notice in place of the Manager, in accordance with the*
- 12 *information most recently provided in writing by the Permittee for the Manager, or by the Manager for*

- 22 SEC. 1070.5. DETERMINATION OF APPLICATION.
- 23 The procedures and standards set forth in Section 1060.5 of this Code shall govern the review
- 24 *and determination of applications for Extended-Hours Premises Permits.*
- 25

1 (a) When an application is filed for a new permit under this Article, the Entertainment 2 Commission shall fix a time and place for a public hearing thereon to determine whether issuance of 3 the permit would result in any of the conditions set forth in Subsection (e). The hearing must be held within 45 working days of the date the completed application is received. 4 5 (b) At the time of filing of an application, the applicant shall notify the Entertainment 6 *Commission of any outstanding requests for permits or approvals from other City departments relating* 7 to the premises of the proposed extended-hours premises. The Entertainment Commission shall notify 8 those departments of the filing of the application. Those departments shall complete all necessary 9 inspections and report their determinations to the Entertainment Commission within 20 working days 10 of the filing of the application. (c) Not less than 30 days before the date of such hearing, the Entertainment Commission shall 11 12 cause to be posted a notice of such hearing in a conspicuous place on the property in which or on 13 which the proposed extended-hours premises is to be operated. Such notice shall set forth the specific 14 type of entertainment which the applicant intends to conduct. Such posting of notice shall be carried 15 out by the Entertainment Commission, and the applicant shall maintain said notice as posted the required number of days. Notice of such hearing shall be mailed by the Chief of Police at least 30 days 16 17 prior to the date of such hearing to any person who has filed a written request for such notice. 18 (d) At the hearing, the applicant and any other interested party, including the Police Department or any other public agency, shall be allowed to introduce evidence and present argument. 19 20 The Entertainment Commission shall make a final decision upon the application at a public hearing, 21 and shall notify the applicant, and any other interested party who has made a written request, of the 22 final decision by first class mail. 23 (e) No time limit shall commence running until the submission of a completed application. 24 Upon the applicant's request, the Entertainment Commission shall continue the hearing to allow the 25 applicant opportunity to comply with the requirements of this Article or any other State or local law.

1	Upon the applicant's request, the Entertainment Commission shall also issue a conditional approval of
2	the permit application, pending approval of the permit by other City agencies, if sufficient information
3	has been provided to allow for adequate evaluation of the proposal and if grounds for denial, as set
4	forth in Subsection (f), are not present.
5	(f) The Entertainment Commission shall grant a permit pursuant to this Article unless he or she
6	<i>finds that:</i>

- 16 (b)(1) ISSUANCE OF ORDER; RIGHT TO APPEAL TO COMMISSION. On the day that the
- 17 <u>Director issues an order of limited suspension, the Director shall send the order to the Permittee and</u>
- 18 <u>Manager by mail or electronically. The order shall state the date that the order issued and the date</u>
- 19 *that it takes effect. To provide the Permittee with an opportunity to file an appeal to the Entertainment*
- 20 *Commission, an order of limited suspension shall not take effect for at least five City business days*
- 21 *from the date that the Director issues the order.*
- 22 (2) A Permittee may appeal an order of limited suspension to the Entertainment

17	(c) EFFECTIVE DATE AND TIME OF ORDER. The order of suspension for public safety
18	issued under this Section shall take effect at the date and time stated in the order.

12	the complaint (by way of example but not limitation, noise, overcrowding, altercation, criminal

1 SEC. 1036. PROSPECTIVE MORATORIUM ON GRANT OF EXTENDED-HOURS 2 PREMISES PERMITS AND PROSPECTIVE LIMIT ON ONE TIME EVENT PERMITS GOING 3 **BEYOND 2:00 A.M.** (a) Within two weeks on either side of the yearly anniversary of the effective date of 4 , the Entertainment Commission shall hold an annual hearing to 5 Ordinance No. determine whether there has been a substantial increase since the effective date of 6 7 Ordinance No. in the number of Extended-Hours Premises Permits in existence 8 and/or in the granting of One-Time Event Permits with authorization for the event to go 9 beyond 2:00 a.m. To make this determination as to Extended-Hours Premises Permits at the first annual 10 hearing, the Commission shall compare the number of such permits in existence at the time of 11 12 the hearing to the number of such permits in existence as indicated in the report submitted 13 pursuant to Section 1070.35(h). To make this determination at subsequent annual hearings. the Commission shall compare the number of such permits in existence at the time of the 14 hearing to the number of such permits in existence at the time of the last annual hearing. 15 To make this determination as to One Time Event Permits at the first annual hearing, 16 17 the Commission shall compare the number of such permits with authorization for the event to 18 go beyond 2:00 a.m. that were granted since the effective date of Ordinance No. with the number of such permits with authorization for the event to go beyond 19 20 2:00 a.m. as indicated in the report submitted pursuant to Section 1070.35(h). To make this determination at subsequent annual hearings, the Commission shall compare the number of 21 such permits with authorization to go beyond 2:00 a.m. that were granted since the last 22 23 annual hearing with the number of such permits with authorization to go beyond 2:00 a.m. that were granted for the period measured at the last annual hearing. 24 25

1	(b) If the calculation mandated by subsection (a) of this Section demonstrates an
2	increase of 15% or more in any year in the number of Extended-Hours Premises Permits in
3	existence, there shall be a City-wide moratorium on the granting of additional Extended-Hours
4	Premises permits. In lieu of a City-wide moratorium, the Entertainment Commission shall
5	have discretion to impose a moratorium applicable only to certain geographic areas of the City
6	in which there is a concentration of Extended-Hours Premises Permits. In this context, a
7	"concentration of Extended-Hours Premises Permits" means geographic areas in the City that
8	have the largest number of Extended-Hours Premises Permits and that cumulatively account
9	for at least 70% of the Extended-Hours Premises Permits in existence as of the hearing
10	mandated by subsection (a) of this Section. In this context, the Commission may define
11	"geographic areas" by reference to Police Districts, zoning provisions of the Planning Code, or
12	other measures that are reasonable in light of other provisions in City law or commonly
13	understood notions of the contours of various San Francisco neighborhoods. The
14	Commission may exercise its discretion to impose the aforementioned moratorium applicable
15	only to certain geographic areas if the Commission makes a finding on the record that
16	considering all factors, including but not limited to economic and public safety concerns, such
17	a moratorium is preferable to a City-wide moratorium.
18	(c) If the calculation mandated by subsection (a) of this Section demonstrates an
19	increase of 15% or more in any year in the number of One Time Event Permits with
20	authorization for the event to go beyond 2:00 a.m., there shall be a limit on the number of
21	future One-Time Event Permits that may be granted with authorization for the event to go
22	beyond 2:00 a.m., as follows: The number of such permits to be issued per year shall
23	correspond to the average number that were issued per year since the inception of the One
24	Time Event Permit or the number that were issued for events occurring in calendar year 2008.
25	whichever number is higher, and adding a factor of 10%. If this limitation is imposed, the

1 Entertainment Commission shall by rule establish criteria for issuing One Time Event Permits 2 with authorization for the event to go beyond 2:00 a.m. If this limitation is imposed but the 3 Commission fails to establish such a rule. One Time Event Permits with authorization for the event to go beyond 2:00 a.m. shall be limited to One Time Events for designated days as 4 5 established by the Commission pursuant to Section 1060.29.1 of this Code, if Ordinance No. 6 is enacted. In determining the criteria for issuing One Time Event Permits with 7 authorization for the event to go beyond 2:00 a.m., the Commission may not consider the 8 content of constitutionally protected expression or entertainment that is part of the event. <u>(d</u>) 9 If a moratorium on Extended-Hours Premises Permits is imposed pursuant to subsection (b) of this Section or a limit on the number of One Time Event Permits with 10 authorization for the event to go beyond 2:00 a.m. is imposed pursuant to subsection (c) of 11 12 this Section, the Entertainment Commission or Director, in consultation with the Police 13 Department, Planning Department, and such other departments as the Commission or Director shall designate, shall conduct a study of the effects of the moratorium and/or 14 limitation, as well as the effects of the substantial increase in the number of Extended-Hours 15 Premises Permits in existence and/or in the granting of One-Time Event Permits with 16 17 authorization for the event to go beyond 2:00 a.m. that gave rise to the moratorium and/or 18 limitation. The study shall be completed no earlier than six months and no later than eleven months after the moratorium and/or limitation is imposed. The Entertainment Commission 19 20 shall hold a hearing on the subject of the study within one month of completion of the study 21 and shall make a recommendation regarding continuing, modifying, or lifting the moratorium and/or limitation. The Police Department and Planning Department, shall participate in the 22 23 hearing and other interested departments may participate in the hearing. Within three months of the Entertainment Commission hearing, the Board of Supervisors or a committee thereof 24 25 shall hold a hearing on the same subject.

1	Section 18. In undertaking the enforcement of this ordinance, the City is assuming an
2	undertaking only to promote the general welfare. It is not assuming, nor is it imposing on its
3	officers and employees, an obligation for breach of which it is liable in money damages to any
4	person who claims that such breach proximately caused injury.
5	Section 1917. SEVERABILITY. If any section, subsection, subdivision, paragraph,
6	sentence, clause or phrase of this Ordinance or of Article 15.2 of the Police Code, or any part
7	thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of
8	competent jurisdiction, such decision shall not affect the validity or effectiveness of the
9	remaining portions of this Ordinance or of Article 15.2, Code or any part thereof. The Board of
10	Supervisors hereby declares that it would have passed each section, subsection, subdivision,
11	paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more
12	sections, subsections, subdivision paragraphs, sentences, clauses or phrases be declared
13	unconstitutional or invalid or ineffective.
14	Section 2018. The Board of Supervisors has adopted findings and a statement of
15	purpose regarding this Ordinance that are set forth in Ordinance No
16
