23	activities in which there are no monetary transactions (admission charge, donation, ticket sales, or		
24	product sales) during or in connection with the activity.

- 1 3. "Individual or Nonprofit Organization" means any person renting the County Fair
- 2 Building or Botanical Garden in his or her individual capacity for private use, or any entity qualifying
- 3 for tax-exempt status under 26 U.S.C. § 501(c)(3), or any garden club or flower society using the
- 4 County Fair Building or Botanical Garden for fundraising activities.
- 5 (b) County Fair Building Facility Rental Fees. All spaces must be rented for a minimum of

6 *two hours*.
