7	WHEREAS, The Presidio Trust has begun the process of changing the Presidio Trust
8	Master Plan (PTMP); and,
9	WHEREAS, The Presidio Trust is anticipated to release the draft Supplemental
10	Environmental Impact Statement (SEIS) containing an analysis of the environmental impacts
11	of developments proposed at the Presidio in early June 2008; and,
12	WHEREAS, The City and members of the public will be given an anticipated 45 day
13	period to comment on the changes to the Presidio Trust Master Plan and Supplemental
14	Environmental Impact Statement; and,
15	WHEREAS, The development in the Presidio and changes thereto could have a
16	tremendous impact upon the City's infrastructure and the demand for City services; and,
17	WHEREAS, The development of the Presidio could have a tremendous impact upon
18	the neighborhoods surrounding the Presidio; now, therefore, be it
19	RESOLVED, That the Board of Supervisors does hereby re-establish the Presidio
20	Neighborhood Representative Work Group, which shall be subject to the mandates of the
21	Sunshine Ordinance; and, be it
22	FURTHER RESOLVED, That the Planning Department shall compile a report
23	containing commentary to the Supplemental Environmental Impact Statement and Presidio
24	Trust Master Plan of The Presidio Neighborhood Representative Work Group which shall be

3	FURTHER RESOLVED, That the City Attorney shall assist the Planning Department in
