14	Section 1. The San Francisco Administrative Code is hereby amended by amending		
15	Section 10G.1, to read as follows:		
16	SEC. 10G.1. SURCHARGE IMPOSED; CATEGORIES OF PERMITS AND FEES.		
17	In order to recover	the cost to the City and County for the Board of Appeals permit	
18	review functions, at the tir	me a fee for permit application, issuance, or review is collected, and	
19	at the time an annual fee for renewal of the permit or license associated with the permit is		
20	collected, a surcharge in the amount specified shall be charged and collected for the following		
21	categories of permits and fees.
