14	Section 1. The Bo	pard of Supervisors adopts as its own and incorporates by reference
15	herein as though fully set	forth the Planning Department findings in its letter dated April 28,
16	2008 . Said letter stated t	the actions contemplated herein are consistent with the General Plan
17	and in conformance with	the Eight Priority Policies of Planning Code Section 101.1. A copy of
18	said letter is in the Clerk	of the Board of Supervisors File No. <u>080845</u> .
19	Section 2. In the a	abovementioned letter, the Planning Department also determined that
20	the actions contemplated in this Ordinance are in compliance with the California Environmenta	
21	Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is	
22	incorporated herein by reference.	
23	Section 3. In acco	rdance with the Department of Public Works' Order No.
24	177,605, a copy of which is in the Clerk of the Board of Supervisors File No. 080845 and	
25	incorporated herein by re	ference, Board of Supervisors Ordinance No.1061, entitled

1	"Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors
2	Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a
3	new section to read as follows:
4	Section 1580. The official sidewalk width on the southerly side of Golden Gate Avenue shall be
5	as shown on Department of Public Works drawing Q-20-647, copies of which are in the Clerk of the
6	Board of Supervisors File No. 080845.
7	Section 4. Hasting College of the Law, University of California, as is necessary as a
8	result of this Ordinance, shall make arrangements with public utility companies and City
9	Departments for the relocation, modification, or any affected public facilities. Any necessary
10	relocation, modification, or both of such facilities shall be at no cost to the City and County of
11	San Francisco.
