1 [Changing the official sidewalk width – Harrison Street] 2 3 Ordinance amending Ordinance No. 1061 entitled "Regulating the Width of Sidewalks" by adding thereto Section 1581 to change the official sidewalk width on the north side 4 of Harrison Street east of Fourth Street; making environmental findings and findings 5 pursuant to the General Plan and Planning Code Section 101.1; requiring relocation, 6 7 modification, or both of facilities affected by the sidewalk width change. 8 Note: Additions are <u>single-underline italics Times New Roman;</u> deletions are strikethrough italics Times New Roman. 9 Board amendment additions are double underlined. Board amendment deletions are strikethrough normal. 10 11 Be it ordained by the People of the City and County of San Francisco: 12 Section 1. The Board of Supervisors adopts as its own and incorporates by reference 13 herein as though fully set forth the Planning Department findings in its letter dated June 13, 14 2008. Said letter stated the actions contemplated herein are consistent with the General Plan 15 and in conformance with the Eight Priority Policies of Planning Code Section 101.1. A copy of 16 said letter is in the Clerk of the Board of Supervisors File No. 081074. 17 Section 2. In the abovementioned letter, the Planning Department also determined that 18 the actions contemplated in this Ordinance are in compliance with the California Environmental 19 Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is 20 incorporated herein by reference. 21 Section 3. In accordance with the Department of Public Works' Order No. 22 177,682, a copy of which is in the Clerk of the Board of Supervisors File No. 081074 and 23 incorporated herein by reference, Board of Supervisors Ordinance No.1061, entitled 24 "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors 25

1 Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a

- 2 new section to read as follows:
- 3 <u>Section 1581. The official sidewalk width on the north side of Harrison Street shall be as shown</u>
- 4 <u>on Department of Public Works drawing Q-20-665, copies of which are in the Clerk of the Board of</u>
- 5 <u>Supervisors File No.\_081074.</u>
- 6 Section 4. 766 Harrison LLC, as is necessary as a result of this Ordinance, shall make 7 arrangements with public utility companies and City Departments for the relocation,
- 8 modification, or any affected public facilities. Any necessary relocation, modification, or both
- 9 of such facilities shall be at no cost to the City and County of San Francisco.
