14 Section 1. To promote Small Business Week and permit sidewalk sales of
15 merchandise, Public Works Code Section 724.1(b), setting a fee for temporary street space
16 occupancy, is hereby waived on Saturday, May 11, 2019, between the hours of 7 a.m. and 9
17 p.m., for the following areas:

18 9th Avenue between Lincoln Way and Kirkham Street;

19 14th Street between Church Street and Landers Street;

20 18th Street between Eureka Street and Douglass Street;

21 18th Street between Noe Street and Diamond Street;

22 Balboa Street between 33rd Avenue and 38th Avenue;

23 Bush Street between Webster Street and Steiner Street;

24 Arguello Boulevard between Clement Street and Euclid Avenue;

25 California Street between Fillmore Street and Steiner Street;

Castro Street between Market Street and 19th Street;

- 1 Church Street between Market Street and 15th Street;
- 2 Clement Street between Arguello Boulevard and 6th Avenue;
- 3 Divisadero Street between Golden Gate Avenue and Page Street;
- 4 Fillmore Street between Eddy Street and Jackson Street;
- 5 Fillmore Street between Green Street and Filbert Street;
- 6 Gough Street between Green Street and Filbert Street;
- 7 Haight Street between Central Avenue and Stanyan Street;
- 8 Irving Street between 5th Avenue and Funston Avenue;
- 9 Irving Street between 14th Avenue and 18th Avenue;
- 10 Laguna Street between Green Street and Filbert Street;
- 11 Market Street between Castro Street and Church Street;

- 19 Ulloa Street between Claremont Boulevard and Wawona Street;
- 20 Union Street between Gough Street and Steiner Street;
- 21 Valencia Street between Market Street and Cesar Chavez Street;

- 23 West Portal Avenue between Ulloa Street and 15th Avenue.

1 Section 2. All other provisions of Public Works Code Sections 724 et seq. shall remain
2 in full effect.

4 Section 3. Effective Date; Retroactivity.

5 (a) This ordinance shall become effective 30 days after enactment. Enactment occurs
6 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
7 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
8 Mayor's veto of the ordinance.

9 (b) If this ordinance becomes effective after May 11, 2019, this ordinance shall be
10 retroactive to that date.

LEGISLATIVE DIGEST

[Public Works Code - Waiver of Temporary Street Space Occupancy Permit Fee - Small Business Week Sidewalk Sales]

Ordinance waiving the fee required by Public Works Code, Section 724.1(b), for temporary street space occupancy permits on certain designated City streets on Saturday, May 11, 2019, to promote Small Business Week.

Existing Law

Section 724.1(b) of the Public Works Code requires that a fee of \$57.62 per day be charged “[f]or temporary street space occupancy for any purpose other than a building construction operation.”

Amendments to Current Law

This uncodified ordinance would temporarily waive the fee required by Section 724.1(b) of the Public Works Code, in certain parts of the City, in connection with Small Business Week. The fee would be waived between 7 a.m. and 9 p.m. on Saturday, May 11, 2019. If the ordinance were to become effective after May 11, 2019, the ordinance would be retroactive to that date.
