- 6 Section 2. The San Francisco Planning Code is hereby amended by adding Section
 7 263.22, to read as follows:
- 8 SEC. 263.22. MISSION STREET LANDMARKS SPECIAL HEIGHT DISTRICT.

9 The Mission Street Landmarks Special Height District shall apply to Assessors Block 3595 Lot 024 and Assessors Block 3616 Lot 007, which contain designated City Landmarks 10 11 as of the effective date of this Section. In the Mission Street Landmarks Special Height 12 District, as designated on Sectional Map. No. 7SU of the Zoning Map, heights are limited to 85 feet for the front portion of the lot extending from Mission Street to no further than 50 13 14 percent of the total lot depth and to a height of 65 feet for the remainder of the lot depth. 15 Should a project within this Special Height District not receive its first building or site permit 16 within 36 months after receiving a final and effective conditional use authorization, then the 17 applicable heights shall revert back to those in effect on November 18, 2008 be 50-X for 18 Assessors Block 3595 Lot 024, and 50-X/65-B for Assessors Block 3616 Lot 007. However, 19 this 36 month time period shall be tolled until the expiration of the appeal period if no appeal is filed, or if an appeal is filed, final resolution of the appeal the 36-month time period shall be 20 tolled until the expiration of the any appeal period if no appeal is filed, or if an appeal is filed, 21 22 final resolution of the any appeal. This time period also shall be tolled until a final judgment is issued in any litigation challenging the project authorization. The Planning Commission shall 23
