[Settlement of Lawsuit - Brandon Simpson - \$50,000]

Ordinance authorizing settlement of the lawsuit filed by Brandon Simpson against the City and County of San Francisco for \$50,000; the lawsuit was filed on January 11, 2017, in the United States District Court, Northern District of California, Case No. 17-CV-00133 KAW; entitled Brandon Simpson v. City and County of San Francisco, et al.; the lawsuit involves alleged damages stemming from civil rights violations; other material terms of the settlement are that Mr. Simpson's court ordered criminal restitution will be paid from the settlement proceeds.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Brandon Simpson v. City and County of San Francisco et al.</u>, United States District Court, Northern District of California, Case No. 17-CV-00133 KAW by the payment of \$50,000, from which \$1,875.70 will be paid to the Department of Corrections and Rehabilitation. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court, Northern District of California on January 11, 2017, and the following parties were named in the lawsuit: plaintiff Brandon Simpson; defendants City and County of San Francisco, Nicholas Buckley, John Fergus, Andrew Clifford, and Elizabeth Morse.
