3 **Resolution authorizing the Office of Economic and Workforce Development to accept**
4 **and expend a grant in the amount of \$176,532 from the Bay-Peninsula Regional**
5 **Planning Unit's fiscal agent, the North Valley Consortium (NOVA) Workforce Board, to**
6 **develop a regional tech sector apprenticeship network and a strategy for a Bay Area**
7 **apprenticeship model within one or more occupations within the tech sector, for the**
8 **period of April 1, 2019, through September 30, 2020.**

10 WHEREAS, The California Workforce Development Board SlingShot 2.0 Regional Plan
11 Implementation grant seeks to promote regional coordination for industry sector development;
12 and

13 WHEREAS, The SlingShot 2.0 Bay-Peninsula System Design to Advance Tech
14 Apprenticeship application identified a strategy for the development of a regional network to
15 promote tech apprenticeship among key industry stakeholders; and

16 WHEREAS, The Bay-Peninsula Regional Planning Unit, acting as a pass-through
17 agent, granted the Office of Economic and Workforce Development \$176,532 to build a
18 regional tech apprenticeship network and a strategy for a Bay Area apprenticeship model
19 within one or more occupations within the tech sector; and

20 WHEREAS, The grant includes a required match of \$8,300; the source of match is
21 through department general funds; and

22 WHEREAS, The grant does not require an Annual Salary Ordinance amendment; and

23 WHEREAS, The Department proposes to maximize use of available grant funds on
24 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

1 RESOLVED, That North Valley Consortium (NOVA) Workforce Board is the Bay-
2 Peninsula Regional Planning Unit fiscal agent for funding from the California Workforce
3 Development Board; and, be it

4 FURTHER RESOLVED, That the Office of Economic and Workforce Development is
5 responsible for the oversight of Bay-Peninsula Regional Planning Unit State funding for
6 workforce development activities in San Francisco; and, be it

7 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office of
8 Economic and Workforce Development to accept and expend a grant in the amount of
9 \$176,532 from the Bay-Peninsula Regional Planning Unit's fiscal agent, the North Valley
10 Consortium (NOVA) Workforce Board; and, be it


11 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of

13 FURTHER RESOLVED, That the Director of the Office of Economic and Workforce
14 Development is authorized to enter into the Agreement on behalf of the City; and be it

15 FURTHER RESOLVED, That within 30 days of the Agreement being fully executed by
16 all parties, the Office of Economic and Workforce Development shall provide the final
17 Agreement to the Clerk of the Board for inclusion into the official file.
