22 and incorporates by reference herein as though fully set forth the findings made by the San  
23 Francisco Redevelopment Agency, by its letter dated October 12, 2006, that the proposed  
24 subdivision is consistent with the Mission Bay North Redevelopment Plan and Plan  
25 Documents (as such term is defined therein); and be it


1 FURTHER MOVED, That the San Francisco Board of Supervisors hereby authorizes  
2 the Director of the Department of Public Works to enter all necessary recording information on  
3 the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerks  
4 statement as set forth herein; and be it

5 FURTHER MOVED, That approval of this map is also conditioned upon compliance by  
6 the subdivider with all applicable provisions of the Mission Bay Subdivision Code and  
7 amendments thereto.
