15	evaluation consultant(s) that will be responsible for conducting an independent evaluation;

17	WHEREAS, As a condition of receiving the funds the Metta Fund requires DPH to enter	
18	into a Grant Agreement (the "Agreement"), a copy of which is on file with the Clerk of the	
19	Board of Supervisors in File No. 090628, which is hereby declared to be a part of this	
20	resolution as if set forth fully within; and,	
21	WHEREAS, An ASO amendment is not required because funds are not used for	
22	staffing purposes; and,	
23	WHEREAS, The budget includes a provision for indirect costs of \$10,000;	
24	WHEREAS, This grant is one of several that DPH is combining in order to help fund th	
25	cost of the Healthy San Francisco program evaluation; and,
