WHEREAS, DPH was awarded a grant from the CDPR in the amount of \$2,672 for the period of July 1, 2009 through June 30, 2010 to support Pesticide Use Reporting; and,

WHEREAS. The purpose of the Pesticide Use Reporting funding is to gather county information regarding the trends of pesticide use; and,

WHEREAS, As a condition of receiving these funds the CDPR requires DPH to enter into a Grant Agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 090654 \_\_\_\_\_, which is hereby declared to be a part of this resolution as if set forth fully within; and,

WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH for one existing position, Industrial Hygienist (Job Class #6138) at .04 FTE; and,

WHEREAS. The budget does not include a provision for indirect costs because CDPR does not allow it; now therefore, be it

RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant from the CDFA in the amount of \$2,672; and, be it

FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.

FURTHER RESOLVED, That the Controller is directed to designate all positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
