[Urging the State of California to fund HIV/AIDS programs proposed for cuts in the FY 2009-10 state budget.]

Resolution calling on the Governor and California Legislature to fully fund HIV/AIDS programs proposed to be cut in the FY 2009-10 state budget.

WHEREAS, the Governor has proposed \$81 million in cuts to HIV/AIDS programs in FY 2009-10, including a \$12.3 million cut to the AIDS Drug Assistance Programs (ADAP); and,

WHEREAS, an estimated 160,000 Californians were living with HIV/AIDS in 2006 with some 27,000 of those cases in San Francisco; and,

WHEREAS, as estimated one sixth of the 37,000 Californians on ADAP live in San Francisco; and,

WHEREAS, ADAP provides free HIV medications to low-income HIV-positive Californians whose lives would be shortened without access to the program; and,

WHEREAS, the Governor's proposed budget would cut \$68.7 million from vital HIV/AIDS programs including HIV testing, home health care, housing, early intervention for newly diagnosed HIV-positives, epidemiology and HIV prevention; and,

WHEREAS, the bulks of these funds are distributed to the counties to support much needed programs; and,

WHEREAS, California has been a model for prioritizing HIV/AIDS care, and these cuts would signify a huge step backward for the standard of care and support services necessary to access that care; and,

WHEREAS, the proposed cuts will increase new cases of HIV and result in greater costs for care and treatment of people who could have avoided HIV infection; now, therefore, be it

RESOLVED that the SF Board of Supervisors opposes proposed cuts to state HIV/AIDS programs in the FY 1009-10 budget; and, be it

FURTHER RESOLVED that the San Francisco Board of Supervisors urges Governor Arnold Schwarzenegger and the California Legislature to continue to fund the HIV/AIDS programs at their FY 2008-09 levels, with necessary growth in funding for ADAP to meet increased enrollment.
