WHEREAS, Federal law provides that when a business opens its doors to the public, it should be open to everyone on the same terms regardless of race, color, religion, creed, national origin, ancestry, sex, age, physical or mental disability, veteran status, genetic information or citizenship; and

WHEREAS, The State of California provides that businesses also should not discriminate on the basis of gender, sexual orientation, gender identity, gender expression or marital status; and

WHEREAS, Even when anti-discrimination laws are in place, people are often still harassed, policed, and even denied goods or services based on their race, color, religion, creed, national origin, ancestry, sex, age, physical or mental disability, veteran status, genetic information, citizenship, gender, sexual orientation, gender identity, gender expression or marital status; and
