

We need peaceful open space for peace of mind. It's good for the soul




they should consider population density

It is inequitable most neighborhoods have many open spaces we only have ONE


We live in a small apartment and we need a place where we can just relax

My name is Charles Whitfield. I'm a renter living in D6, and I'm writing to urge you to support the proposed housing development at the corner of Russ & Folsom streets in my neighborhood.

This project is a great opportunity to add much-needed housing without displacement. As a renter in D6, I see first-hand the rent increases that come when the new housing isn't built to keep up with job growth. Please help the renters in D6 and across the city by supporting this project!

Additionally, I would love to see you and your team work to allow more housing to be built all across the city, especially in historically exclusionary neighborhoods. I've been really impressed by your commitment to improving non-car transportation in the district, and by your support of the Seawall Navigation Center on the Embarcadero. In your comments about the Nav Center, you voiced support for the center but also stressed the importance of all 11 districts of San Francisco doing their part to support individuals experiencing homelessness.

The same is true of the housing crisis! New housing in D6 is helpful and should be approved, but other districts are not doing enough. Most districts across the city are able to avoid new housing by virtue of their exclusionary zoning. I hope you'll approach the housing crisis with the same attitude and perspective that you've applied to the Nav Center issue.

Dear President Yee:

I am writing to urge you and your colleagues to grant the appeal of the Folsom/Russ project at today's meeting.

I served on the Recreation and Parks Commission for twelve years. In that time, we had a handful of votes asking to allow exemptions to the shadow ordinance in the case of projects that either had 'minimal' impact on parks properties or had minimal impact but whose project's benefit to the community allowed us, as a commission, to agree to an exemption.

This project, in a far smaller iteration, came before us in 2015. There was no question the impact on the park was significant AND the benefit of the project to the community so insignificant that rejecting their request to waive the shadow law arguably was one of our easier votes as a commission.

Now the project is far bigger, far denser and the shadow impact considerably greater than in 2015. Sadly, and almost inexplicably, my colleagues on the Recreation and Park Commission saw fit to approve the project nonetheless.

I urge you to take a stand, to respect that we have a law that protects light in our parks and that the public's trust of longstanding laws intended to serve the good of our citizens (and parks) are worth fighting for. This project has nothing compelling to it to suggest it deserves an exemption. Increasing the number of affordable housing units appeases concerns as to the project's density, NOT to its shadow impacts.

We cannot continue to say we care about communities of color and care about our open space and care about ensuring some element of a quality of life in neighborhoods that are fast becoming overbuilt when votes like this go in favor of developers. PLEASE think of the South of Market neighborhood and the impact this has on the Manalo Draves Park and the community it so significantly serves.

Think, too, the impact of your vote today, in the long term. I have long felt allowing exemptions for shadow impacts is a slippery slope. Obviously we're already at the bottom of that slope. But at least when we have allowed shadows in the past, the community benefited in a real and meaningful way. This is not one of those instances.
