In the event that this ordinance is approved prior to the adoption of the Annual Salary Ordinance for FY 2009-2010, the Controller shall amend the Interim Annual Salary Ordinance to reflect this position authority.

Section 2. Authorization to Accept and Expend Funds.

This Ordinance authorizes the Human Services Agency to accept and expend a grant in the amount of \$28,141,437 \$26,505,777 for the operation of a subsidized employment program known as Jobs NOW. The United States Department of Health and Human Services provides funds to the City and County of San Francisco, through the California Department of Social Services, to operate the California Work Opportunity and Responsibility to Kids (CalWORKs) Program. CalWORKs funds include local state dollars as well as federal Temporary Aid to Needy Families (TANF) dollars. With the passage of the American Recovery and Reinvestment Act (ARRA), Congress expanded the kinds of expenses that can be reimbursed with TANF funds. HSA will be able to claim reimbursement for 80% of expenses associated with subsidized employment programs and related ancillary services for current and former recipients of CalWORKs aid. Pending state guidance, HSA may also be authorized to spend TANF funds on a broader population as well, including non-custodial parents and families earning income less than 200% of the Federal Poverty Level.
