

## ORDINANCE NO.

[Settlement of Lawsuit - Fidelia del Carmen May Can, Rosana Guadalupe Gongora May, Luis Rodolfo Gongora May, and Angel de Jesus May - \$140,000]

Ordinance authorizing settlement of the lawsuit filed by Fidelia del Carmen May Can, Rosana Guadalupe Gongora May, Luis Rodolfo Gongora May, and Angel de Jesus May against the City and County of San Francisco for \$140,000; the lawsuit was filed on October 11, 2016, in United States District Court, Case No. 16-cv-05771; entitled <u>Fidelia</u> <u>del Carmen May Can, et al. v. City and County of San Francisco, et al.</u>; the lawsuit involves alleged civil rights violation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Fidelia del Carmen May Can, et al. v.</u> <u>City and County of San Francisco, et al.</u>, United States District Court, Case No. 16-cv-05771 by the payment of \$140,000. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court on October 11, 2016, and the following parties were named in the lawsuit: plaintiffs: Fidelia del Carmen May Can, Rosana Guadalupe Gongora May, Luis Rodolfo Gongora May, and Angel de Jesus May; defendants: City and County of San Francisco, Sgt. Nathaniel Steger #2252 and Officer Michael Mellone #4249.
