11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Fidelia del Carmen May Can, et al. v.
13 City and County of San Francisco, et al., United States District Court, Case No. 16-cv-05771
14 by the payment of \$140,000. The lawsuit involves alleged civil rights violations.

15 Section 2. The above-named action was filed in United States District Court on
16 October 11, 2016, and the following parties were named in the lawsuit: plaintiffs: Fidelia del
17 Carmen May Can, Rosana Guadalupe Gongora May, Luis Rodolfo Gongora May, and Angel
18 de Jesus May; defendants: City and County of San Francisco, Sgt. Nathaniel Steger #2252


