3	WHEREAS, San Francisco Charter Section 9.118(b) requires Board approval by		
4	resolution for amendments of \$500,000 or more to agreements that exceed \$10 million; and,		
5	WHEREAS, the proposed ninth amendment is on file with the Clerk of the Board of		
6	Supervisors in File No. <u>091069</u> , which is hereby declared to be a part of this resolution as if set		
7	forth fully herein; now, therefore be it		
8	RESOLVED, that the Board of Supervisors approves the ninth amendment to the		
9	agreement, increasing the dollar amount by \$1,424,559, for a total of \$20,770,000, and extending		
10	the performance period through March 31, 2010 or when a new office supplies contract is in		
11	place, whichever is sooner; and be it		
12	FURTHE RESOLVED, that the Board encourages the Controller's Office to finish its		
13	audit of the current office supplies contract and findings for how to improve the current office
