Dear Supervisor Peskin & Staff,

We would like to meet with you in order to get on the same page with regard to our pending Type 42 Dept. of ABC license application for the Museum of Ice Cream.

From what we understand (and please let us know if we're missing anything) your primary concerns were in our hours, security, and general details of our operations. We hope this letter provides some information that we can go over in person at your earliest convenience. We are getting close to being ready to open and want to make sure our operation plans for the space are suitable.

This adult-only space requires ID checks for all guests entering the mezzanine. Staff security will be stationed at the base of the stairwell leading to the wine bar area. Staff are clearly identifiable by their brightly colored and marked uniforms. At all times that guests are in the store/entry area as well as the mezzanine, they are visible to our staff.

We've adjusted our requested hours on our ABC application to be 11am – midnight (Sun – Wed) and 11am – 1am (Thur - Sat) to hopefully address your concern for morning intoxication on the streets of District 3. We anticipate closing well before midnight most nights as many of our staff rely on BART to get home. We will send over a copy of these signed conditions once we receive them from Dept. of ABC.

We are asking for the later hour to accommodate special events and fundraisers that we are known for hosting. We have hosted numerous events for the city including the launch of Small Business Saturday with Mayor Ed Lee, fundraising events for Creative Growth in Oakland, Downtown Streets Teams, a Voting Initiative with Mayor Breed, amongst many others in the bay. In total, we have donated over \$250,000 to nonprofits since we opened in 2017.

The mezzanine will be staffed by 3-5 employees per shift, so there will be ample monitoring of patrons and beverages. Misbehaving clientele are not our typical parent and tourist audience but if they appear will be quickly addressed and never over-served as the mezzanine space is visually open to the first floor and that would negatively impact the mood of the whole premises and materially harm our family friendly Museum. Maintaining a positive, fun environment for everyone is a top priority. Museum guests can stop in before or after their tour and it is open to the public, just like our gift shop. We anticipate our busiest hours will be 3-8pm.

in terms of exterior security, we have some unique needs based on our popularity and our location. As you may have seen, our tickets sell out quickly and queues form around the block from Grant Street to O'Farrell. This has been the case in our New York City and Los Angeles locations as well. We have a system of staff monitoring this space and keeping the energy positive so guests are in a good mood when they enter the space and a good mood when they leave. We also feel that having this option for guests will reduce the number of people waiting outside.






