9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Timothy Doyle v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-555897 by the
13 payment of \$75,000. The lawsuit involves alleged personal injury from a vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 December 13, 2016, and the following parties were named in the lawsuit: Timothy Doyle,
16 plaintiff, City and County of San Francisco; Officer Jared Harris; and Does 1 to 100,






