1 [Supporting California State Senate Bill No. 686 (Allen) - California Promise Neighborhoods  
2 Act of 2019]

3 **Resolution supporting California State Senate Bill No. 686, authored by Senator Ben**  
4 **Allen, which would enact the California Promise Neighborhoods Act of 2019.**

5  
6 WHEREAS, In 2012, the City of San Francisco, San Francisco Unified School District  
7 and the Mission Economic Development Agency (MEDA) joined efforts with more than 20  
8 citywide and youth-serving community partners to launch Mission Promise Neighborhood  
9 (MPN) as an urgent response to bridge family economic security with student academic  
10 achievement in the Latino community; and

11 WHEREAS, MPN is a community effort based at nine San Francisco Unified School  
12 District schools and three family resource centers that connects thousands of families to  
13 services for infants, children and adults in the Mission District of San Francisco, including child  
14 care, preschool, health care, housing, tax preparation, immigration assistance, financial  
15 coaching, job training and more; and

16 WHEREAS, In its seventh year of implementation and in alignment with citywide  
17 strategic goals, MPN has seen impressive outcomes for children and youth, such as  
18 increased graduation rates, significant gains in kindergarten-readiness, and improved service-  
19 delivery and accountability through data-sharing agreements and a shared referral database;  
20 and

21 WHEREAS, These outcomes are even more impressive considering the extreme  
22 pressures Mission Promise Neighborhood families are experiencing, including unprecedented  
23 levels of housing displacement and growing income inequality, coupled with a national  
24 political climate translating to an assault on their community; and

1           WHEREAS, California currently has five Promise Neighborhoods, including MPN in  
2 San Francisco, YPI in Los Angeles, Chula Vista/San Diego Promise, Hayward Promise, and  
3 Coming Promise, each achieving impressive academic outcomes; and

4           WHEREAS, Promise Neighborhoods are community-based provider networks with a  
5 common agenda, shared measurement systems, mutually reinforcing activities, continuous  
6 communication, and a backbone organization, leading to cradle-to-college-to-career  
7 wraparound supports and communities of opportunity for children and families; and

8           WHEREAS, Promise Neighborhoods are highly effective because they are collective  
9 impact initiatives that are results and data-driven, place-based, community-powered and  
10 equity-focused; and

11           WHEREAS, Federal funding for existing Promise Neighborhoods is not assured, and  
12 more Promise Neighborhoods are needed throughout the state because all children -  
13 regardless of their family's socioeconomic status - deserve access to coordinated academic,  
14 health, social, and other support services that will prepare them to succeed in college and  
15 career and contribute to the wealth of our state and nation; and

16           WHEREAS, Senator Ben Allen (D-Los Angeles) introduced Senate Bill No. 686 (SB  
17 686), the California Promise Neighborhoods Act of 2019, that would ensure the continued  
18 funding of California's existing Promise Neighborhoods, including San Francisco's Mission  
19 Promise Neighborhood, and expand this successful model to more neighborhoods in our  
20 state; now, therefore, be it

21           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
22 joins with other local jurisdictions and a growing statewide coalition of education, social justice  
23 and equity advocates in supporting SB 686; and, be it

1           FURTHER RESOLVED, That the Board of Supervisors of the City and County of San  
2 Francisco directs the Clerk of the Board to transmit copies of this Resolution to the State  
3 Legislature and the City Lobbyist upon passage.

An act to add Chapter 17 (commencing with Section 11550) to Part 7 of Division 1 of Title 1 of the Education Code, relating to pupil support services.

LEGISLATIVE COUNSEL'S DIGEST

SB 686, as amended, Allen. California Promise Neighborhoods Act of 2019.

Existing law establishes a system of public elementary and secondary schools in this state, and authorizes local educational agencies throughout the state to operate schools and provide instruction to pupils in kindergarten and grades 1 to 12, inclusive. Existing law establishes the State Department of Education, under the administration of the Superintendent of Public Instruction, and assigns to the department numerous duties relating to the financing, governance, and guidance of the public elementary and secondary schools in this state.

This bill would enact the California Promise Neighborhoods Act of 2019. The bill would establish the California Promise Neighborhood Grant Program, to be administered by the department, to award grants, on a competitive basis, *except as specified*, to eligible entities to implement a comprehensive, integrated continuum of *cradle-to-college-to-career* solutions—or *through a pipeline of coordinated* services based on the best available evidence in

neighborhoods with high concentrations of low-income families, persistently low-achieving schools or schools with an achievement gap, schools identified for differentiated assistance or intensive intervention, and other indicators of at-risk youth or high need. The bill would require the department to develop an application process for eligible entities to apply to become Promise Neighborhoods consistent with specified criteria. The bill would require the department to establish performance standards to measure progress on indicators and results relevant to the evaluation of the grant program, including prescribed results and indicators.

The bill would require the department to competitively award grants, each not to exceed \$5,000,000, to 20 eligible entities across the state for the 2020–21 fiscal year, to be disbursed over a period of 5 fiscal years contingent on grant recipients meeting the performance metrics described and achieving annual goals for growth on program and project indicators, as determined by the department. year, except as specified. The bill would require each grant recipient to contribute matching funds in an amount equal to not less than 100% of the grant award, with at least 10% coming from private sources. sources, except as specified. The bill would require each grant recipient to prepare and submit an annual report to the department that includes specified information relating to the expenditures and outcomes of programs provided by the grant recipient. The bill would provide that the operation of these provisions is contingent on the enactment of an appropriation in the annual Budget Act for these purposes.

*The people of the State of California do enact as follows:*

- 1 SECTION 1. The Legislature finds and declares all of the
- 2 following:
- 3 (a) All children throughout the state, regardless of their family's
- 4 socioeconomic, English learning, or special education status or
- 5 what neighborhoods they reside in, deserve access to a high-quality
- 6 education, health services, and social services that will prepare
- 7 them to succeed in college and in their careers, and that will allow
- 8 them to become productive citizens contributing to the wealth of
- 9 our state and nation.

1 (b) Many children living in California’s most distressed  
2 communities lack access to opportunities that will ensure adequate  
3 academic, social, and health preparation for achieving success and  
4 help end family and neighborhood poverty.

5 (c) Innovative and comprehensive *collective impact* approaches  
6 to break the cycle of poverty are necessary for creating  
7 opportunities for children to succeed and ultimately help turn  
8 around poor neighborhoods.

9 (d) Long-term investments in underserved children’s academic,  
10 social, and health development and the strengthening of a system  
11 of family and community support shared by various  
12 *cradle-to-college-to-career* stakeholders are also needed to sustain  
13 the future of our communities in California.

14 (e) Through ~~collaborative~~ *collaborative, two-generation* efforts  
15 illustrated in this measure, the communities and cities in California  
16 are encouraged to provide services and resources more efficiently  
17 and effectively to meet the needs of ~~children and families~~ *the whole*  
18 *child, whole family, and whole community* in California’s poorest  
19 neighborhoods.

20 (f) *The place-based, equity-focused approach of Promise*  
21 *Neighborhoods supports implementation of “The California Way,”*  
22 *the initiative by the State Department of Education to engage*  
23 *pupils, parents, and communities as part of a collaborative*  
24 *decision-making process around how to fund and implement local*  
25 *improvement efforts, and provide supplemental resources to ensure*  
26 *that California’s English learners, foster youth, and pupils in*  
27 *poverty have the learning supports they need.*

34 11550. This chapter shall be known, and may be cited, as the  
35 California Promise Neighborhoods Act of 2019.

36 11551. For purposes of this chapter, the following definitions  
37 apply:

38 (a) *“Cradle-to-college-to-career” means a system of integrated*  
39 *services, both public and private, which begins in the early years*  
40 *of a child’s life and leads to appropriate postsecondary success*

1 for all pupils and students that includes academic, occupational,  
2 and independent living that benefits the individual and community  
3 as a whole.

5 (b) (1) "Eligible entity" means a nonprofit organization,  
6 including faith-based organizations to the extent permitted by law,  
7 an institution of higher education, or an Indian tribe or tribal  
8 organization, serving as a lead agency representative of the  
9 proposed geographic area to be served and in partnership with at  
10 least one public elementary or secondary school, traditional or  
11 charter, or school district located within the identified geographic  
12 area.

13 (2) An eligible entity may include other entities in the  
14 partnership, including, but not limited to, any of the following  
15 entities, though these organizations may not inhabit the lead role:

16 (A) A school, traditional or charter, school district, or  
17 superintendent of a school district within the designated geographic  
18 boundary.

19 (B) An institution of higher education.

20 (C) The office of a chief elected official or a unit or agency of  
21 local government.

22 (D) Health organizations within the designated geographic

18 shall choose to measure and report on two or more family and  
19 community support results and indicators. Grantees' project design  
20 and implementation of a whole community continuum of solutions  
21 are subject to, but not limited to, the following family and  
22 community support results and indicators:

35 statement of need in the neighborhood shall be based, in part, on  
36 results of a comprehensive needs assessment and segmentation  
37 analysis. The application may propose to serve multiple,  
38 noncontiguous areas.

39 (3) A description of the applicant's measurable short-term,  
40 long-term, and annual goals for expected outcomes of the grant,

1 based on program and project indicators, as described above, that  
2 includes all of the following:

3 (A) Performance goals for each year of the grant.

4 (B) Projected participation rates over time and any plans to  
5 expand the number of children served over time by the grant  
6 program.

7 (C) Annual goals for evaluating progress in improving systems,  
8 such as changes in policies, environments, or organizations that  
9 affect children and youth in the neighborhood.

10 (4) An analysis of the needs and assets of the neighborhood  
11 identified, including all of the following:

12 (A) A description of the process through which the needs  
13 assessment and segmentation analysis was produced, including a  
14 description of how family and community members were engaged  
15 in the analysis.

16 (B) An explanation of how the applicant will use the needs  
17 assessment and segmentation analysis to determine the children  
18 with the highest needs and ensure that those children receive the  
19 appropriate services from the continuum of  
20 *cradle-to-college-to-career* solutions.

21 (C) A description of both the academic indicators and the family  
22 and community support indicators that the applicant will use in  
23 conducting the needs assessment.

24 (5) (A) A description of solutions that will be used in the  
25 continuum of *cradle-to-college-to-career* solutions based on data  
26 collected, including a description of solutions specifically targeting  
27 children, family members, community members, and children not  
28 attending schools or programs operated by the applicant and its

35 (A) A description of the metrics that will be used to inform each  
 36 solution of the pipeline.

37 (B) The processes for using data to improve instruction, optimize  
 38 integrated pupil supports, provide for continuous program  
 39 improvement, and hold staff and partner organizations accountable.

1 (10) An identification of the fiscal agent, which may be any  
2 eligible entity.

3 (11) A list of federal, state, local, and private sources of funding  
4 that the applicant will secure to comply with the matching funds  
5 requirement in Section 11555.

6 (c) Before receiving a grant under this chapter, the applicant  
7 shall do all of the following:

8 (1) Collect data, including publicly available data, for the  
9 academic indicators and use them as ~~both~~ program and project  
10 indicators.

11 (2) Collect data, including publicly available data, for the family  
12 and community support indicators and use them as program and  
13 project indicators.

14 (3) Perform an analysis of community assets within, or  
15 accessible to, the neighborhood, including, at a minimum, all of  
16 the following:

17 (A) Early learning programs and networks, including home  
18 visiting, high-quality child care, Early Head Start programs, Head  
19 Start programs, and prekindergarten programs.

20 (B) Community centers, after school programs, and other  
21 opportunities for activities outside of school hours.

22 (C) Transportation.

23 (D) Parks.

24 (E) The availability of healthy food options and opportunities  
25 for physical activity.

26 (F) Existing family and pupil supports.

27 (G) Businesses and employers located in the community.

28 (H) Institutions of higher education.

29 (4) Provide evidence of successful collaboration that has led to  
30 changes in child outcomes within the neighborhood.

31 (d) An eligible entity, as part of the application, shall submit a
