3 **Ordinance amending the Planning Code to allow operation of a farmers market on the**
4 **Department of Motor Vehicles Field Office parking lot at 1377 Fell Street; affirming the**
5 **Planning Department's determination under the California Environmental Quality Act;**
6 **making findings of consistency with the General Plan, and the eight priority policies of**
7 **Planning Code, Section 101.1; and adopting findings of public necessity, convenience,**
8 **and general welfare under Planning Code, Section 302.**

14 Be it ordained by the People of the City and County of San Francisco:

15

16 Section 1. Findings.

17

(a) The Planning Department has determined that the actions contemplated in this
18 ordinance comply with the California Environmental Quality Act (California Public Resources
19 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
20 Supervisors in File No. _____ and is incorporated herein by reference. The Board
21 affirms this determination.

22

(b) On _____, the Planning Commission, in Resolution No. _____, adopted
23 findings that the actions contemplated in this ordinance are consistent, on balance, with the
24 City's General Plan and eight priority policies of Planning Code Section 101.1. The Board

1 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
2 Board of Supervisors in File No. _____, and is incorporated herein by reference.

3 (c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this
4 ordinance will serve the public necessity, convenience, and general welfare for the reasons
5 stated in Planning Commission Resolution No. _____.

6
7 Section 2. The Planning Code is hereby amended by revising Section 205.4, to read
8 as follows:

9 **SEC. 205.4. TEMPORARY USES: INTERMITTENT ACTIVITIES.**

10 An intermittent activity is an outdoor use which, while occasional, occurs with some
11 routine or regularity. Intermittent activities include, but are not limited to, the following uses:
12 mobile food facilities, farmers markets, and open-air craft markets. Such uses typically require
13 additional authorization(s) from other City Departments. An intermittent activity may be
14 authorized as a temporary use for a period not to exceed one year.

15 * * * *

16 (b) An intermittent activity is allowed in a RH, RM, RED, and RTO District only if it: (1)
17 satisfies all the conditions set forth in Subsection (a); and (2) is located on a parcel that
18 contains or is part of a Hospital, as defined in Section 102, ~~or~~ a Post-Secondary Educational
19 Institution, as defined in Section 102, or a Public Facility, as defined in Section 102. An
20 intermittent activity authorized under this Subsection shall not operate between the hours of
21 10:00 p.m. to 7:00 a.m.

22
23 Section 3. Effective Date. This ordinance shall become effective 30 days after
24 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the

1 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
2 of Supervisors overrides the Mayor's veto of the ordinance

3
4 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
5 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
6 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
7 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
8 additions, and Board amendment deletions in accordance with the "Note" that appears under
9 the official title of the ordinance.
