4 **Resolution approving the FY2019-2020 Housing Opportunities for Persons with AIDS**
5 **("HOPWA") Program; and authorizing the Mayor, on behalf of the City and County of**
6 **San Francisco, to apply for, accept, and expend the City's FY2019-2020 HOPWA**
7 **Program entitlement from the United States Department of Housing and Urban**
8 **Development in the amount of \$7,520,360 and to expend program income of \$50,000 for**
9 **a combined total of \$7,570,360 for the period of July 1, 2019, through June 30, 2024.**

11 WHEREAS, Under the AIDS Housing Opportunity Act, Subtitle D of Title VIII of the
12 National Affordable Housing Act of 1990, Public Law Number 101-625, the City and County of
13 San Francisco is eligible to apply for and receive funds from the Housing Opportunities for
14 Persons with AIDS (HOPWA) Program; and

15 WHEREAS, The City and County of San Francisco anticipates receiving
16 approximately \$7,520,360 in FY2019-2020 HOPWA Program funds from HUD and has
17 approximately \$50,000 in anticipated Program Income, for a combined total of approximately
18 \$7,570,360; and

19 WHEREAS, The City and County of San Francisco is responsible for distributing a
20 portion of the HOPWA funds to the County of San Mateo as the lead agency for the San
21 Francisco Eligible Metropolitan Statistical Area (EMSA); and

22 WHEREAS, The Mayor's Office of Housing and Community Development (MOHCD)
23 has prepared programs and a proposed Expenditure Schedule for FY2019-2020 HOPWA
24 funding, including the distributions to the County of San Mateo, a copy of which is located in
25 Clerk of the Board of Supervisors File No. _____ (the "Expenditure Schedule"); and

1 WHEREAS, The proposed grant does not require an Annual Salary Ordinance
2 amendment; and

3 WHEREAS, The funding agency (HUD) does not allow use of grant on indirect costs;
4 now, therefore, be it

5 RESOLVED, That the Mayor of the City and County of San Francisco is hereby
6 authorized to apply for, accept, and expend the City's FY2019-2020 HOPWA Program
7 entitlement grant from HUD and expend an estimated \$50,000 in Program Income, all in
8 accordance with the purposes and goals for the funding as generally set forth in the 2015-
9 2019 Five Year Consolidated Plan and the Expenditure Schedule; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors does hereby approve the
11 purposes and goals for FY2019-2020 HOPWA Program funding as set forth in the
12 Expenditure Schedule for recipient agencies and departments; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
14 indirect costs in the grant budget; and, be it

15 FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute
16 agreements between the City and County of San Francisco and the various agencies
17 consistent with the FY2019-2020 HOPWA Program and the Expenditure Schedule; and, be it

18 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation
19 and certifications as may be requested or required by HUD, and to take such additional
20 actions as may be required to apply for, accept and expend the FY2019-2020 HOPWA funds
21 consistent with this Resolution and the goals of the FY2019-2020 HOPWA Program and all
22 applicable legal requirements, and any such actions are solely intended to further the
23 purposes of this Resolution, and are subject in all respect to the terms of this Resolution, and
24 any such action cannot increase the risk to the City, or require the City to expend any
25 resources, and that the Mayor shall consult with the City Attorney prior to execution and

1 provided that within 30 days of the agreements approved by this Resolution being executed
2 by all parties, such final documents (showing marked changes, if any) shall be provided to the
3 Clerk of the Board, for inclusion in the official file, together with a brief explanation of any
4 actions from the date of the adoption of this Resolution; and, be it

5 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City
6 with respect to the application for, or the acceptance or expenditure of, FY2019-2020 HOPWA
7 funds as consistent with the documents herein and this Resolution, are hereby approved,
8 confirmed and ratified.






