4 **City and County of San Francisco for \$75,000; the lawsuit was filed on March 19, 2018,**  
5 **in San Francisco Superior Court, Case No. CGC-18-565058; entitled Oscar L. Tomasino**  
6 **v. City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**  
7 **on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Oscar L. Tomasino v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-565058 by the  
13 payment of \$75,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 March 19, 2018, and the following parties were named in the lawsuit: Oscar L. Tomasino,  
16 plaintiff; City and County of San Francisco, defendant.


