Motion withdrawing the Charter Amendment previously ordered submitted by the Board of Supervisors, for the election to be held on November 5, 2019, to establish the Free City College Fund to defray certain costs of City College students, and to require annual appropriations in designated amounts to the Fund (Board File No. 181001).

WHEREAS, On December 18, 2018, the Board of Supervisors ordered submitted to the voters for the November 5, 2019, election a Charter Amendment to establish the Free City College Fund to defray certain costs of City College students, and to require annual appropriations in designated amounts to the Fund, on file with the Clerk of the Board of Supervisors in File No. 181001, submitted pursuant to Section 300(a) of the Municipal Elections Code; and

WHEREAS, Section 370(a) of the Municipal Elections Code provides that any measure submitted to the voters under Section 300(a) of the Municipal Elections Code may be withdrawn by the Board of Supervisors at any time up to the legal deadline for submission of such measures; and

WHEREAS. The Board of Supervisors wishes to withdraw the order of submission of said Charter Amendment for the November 5, 2019, election; now, therefore, be it

MOVED, That pursuant to Section 370(a) of the Municipal Elections Code, the Board of Supervisors hereby withdraws the measure previously submitted to the voters, for the election to be held on November 5, 2019, to establish the Free City College Fund to defray certain costs of City College students and to require annual appropriations in designated amounts to the Fund, on file with the Clerk of the Board of Supervisors in File No. 181001.
