[Settlement of Lawsuit - San Franciscans for Livable Neighborhoods - \$247,799.50]

Ordinance authorizing settlement of the lawsuit filed by San Franciscans for Livable Neighborhoods against the City and County of San Francisco for \$247,799.50; the lawsuit was filed on August 4, 2011, in San Francisco Superior Court, Case No. 513-077; entitled <u>San Franciscans for Livable Neighborhoods v. City and County of</u> <u>San Francisco</u>; the lawsuit involves a challenge to the environmental impact report prepared in support of, and the approval of, the 2009 Housing Element of the San Francisco General Plan.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>San Franciscans for Livable</u> <u>Neighborhoods v. City and County of San Francisco</u>, San Francisco Superior Court, Case No. 513-077, by the payment of \$247,799.50. The lawsuit involves a challenge to the environmental impact report prepared for and approval of the 2009 Housing Element of the San Francisco General Plan.

Section 2. The above-named action was filed in San Francisco Superior Court on August 4, 2011, and the following parties were named in the lawsuit: petitioner San Franciscans for Livable Neighborhoods and respondent City and County of San Francisco.
