9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Fidel Joshua v. City and County of  
12 San Francisco, United States District Court, Northern District of California, Case  
13 No. 14-cv-05394-JD by the payment of \$460,000. The lawsuit involves an employment  
14 dispute.

15 Section 2. The above-named action was filed in United States District Court, Northern  
16 District of California on December 9, 2014, and the following parties were named in the  
17 lawsuit: Plaintiff: Fidel Joshua; Defendant: City and County of San Francisco.


