ORDINANCE NO.

Ordinance authorizing settlement of the lawsuit filed by Joseph Alvarado against the City and County of San Francisco for \$175,000 and appropriating the same amount from the Public Utilities Commission Wastewater Enterprise Fund balance; the lawsuit was filed on September 6, 2018, in San Francisco Superior Court, Case No. CGC-18-569501; entitled Joseph Alvarado v. City and County of San Francisco, et <u>al.</u>; the lawsuit involves alleged personal injuries on a City street; other material term is waiver of Zuckerberg San Francisco General Hospital lien.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Joseph Alvarado v. City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-18-569501 by the payment of \$175,000. The lawsuit involves alleged personal injuries on a City Street; other material term is waiver of Zuckerberg San Francisco General Hospital lien.

Section 2. The above-named action was filed in San Francisco Superior Court on September 6, 2018, and the following parties were named in the lawsuit: Plaintiff: Joseph Alvarado; Defendant: City and County of San Francisco.

Section 3. The source of funding herein appropriated for use by the San Francisco Public Utilities Commission (SFPUC) for purposes of this settlement payment is the SFPUC Wastewater Enterprise Fund balance.
