

[Settlement of Lawsuit - De'Mario Grant - \$175,000]

Ordinance authorizing settlement of the lawsuit filed by De'Mario Grant against the City and County of San Francisco for \$175,000; the lawsuit was filed on September 20, 2017, in the United States District Court, Northern Division of California, Case No. 3:17-CV-04869-WHA; entitled <u>De'Mario Grant v. City and County of San Francisco,</u> <u>et al.</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>De'Mario Grant v. City and County of San Francisco, et al.</u>, United States District Court, Northern Division of California, Case No. 3:17-CV-04869-WHA by the payment of \$175,000.
