1 [Grant Agreement Amendment - Retroactive - San Francisco Unified School District -  
2 Preschool for All - \$17,002,791]

3 **Resolution retroactively approving the second amendment of the grant between the**  
4 **City and County of San Francisco and the San Francisco Unified School District for the**  
5 **provision of preschool support and staff training, to increase the amount by \$7,025,677**  
6 **for a total amount of \$17,002,791 and to extend the grant term by two years to**  
7 **commence July 1, 2019, for the total agreement term of July 1, 2016, through June 30,**  
8 **2021.**

10 WHEREAS, The City and County of San Francisco, wishes to provide preschool  
11 support, raise quality outcomes for early care and education students, and train early  
12 education staff; and

13 WHEREAS, The Office of Early Care and Education, in partnership with the Human  
14 Services Agency, obtained a sole source waiver for these services in December 2016; and

15 WHEREAS, The San Francisco Unified School District submitted a responsive and  
16 responsible proposal and was awarded the grant for the total amount of \$9,977,114 in March  
17 2017; and

18 WHEREAS, An initial modification of the San Francisco Unified School District grant in  
19 the addition of pilot program was requested and approved in June 2018; and

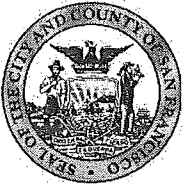
20 WHEREAS, The Office of Early Care and Education, in partnership with the Human  
21 Services Agency is now requesting approval for a second modification of the San Francisco  
22 Unified School District grant in the amount of \$7,025,677 resulting in a new total amount of  
23 \$17,002,791 with an extended term to June 30, 2021; now, therefore be it

24 RESOLVED, That the Board of Supervisors hereby approves modification of the  
25 agreement with the San Francisco Unified School District, increasing the amount by

1 \$7,025,677 resulting in a revised total amount of \$17,002,791 for the period of July 1, 2016 to  
2 June 30, 2021; and, be it

3 FURTHER RESOLVED, That within thirty (30) days of the modification being fully  
4 executed by all parties, the Human Services Agency shall provide the final agreement to the  
5 Clerk of the Board for inclusion into the official file.
