7 WHEREAS, The Board of Supervisors wishes to authorize the listed Board Members or
8 sponsor, supporting the following ballot measures, to prepare and submit a written proponent
9 ballot arguments and proponent rebuttal arguments for submittal to the Director of Elections:

- 10 ▪ Charter Amendment (First Draft) to amend the Charter of the City and County of
11 San Francisco to change the name of the Aging and Adult Services Commission to
12 the Disability and Aging Services Commission, and establish qualifications for three
13 of the Commission seats; change the name of the Department of Aging and Adult
14 Services to the Department of Disability and Aging Services; and to change the
15 name of the Aging and Adult Services Community Living Fund to the Disability and
16 Aging Services Community Living Fund; at an election to be held on November 5,
17 2019. (Board File No. 190570) (President Yee)
- 18 ▪ Ordinance calling and providing for a special election, for the purpose of submitting
19 to San Francisco voters a proposition to incur bonded indebtedness of not-to-
20 exceed \$600,000,000 to finance the construction, development, acquisition,
21 improvement, rehabilitation, preservation, and repair of affordable housing
22 improvements, and related costs necessary or convenient for the foregoing
23 purposes; authorizing landlords to pass-through 50% of the resulting property tax
24 increase to residential tenants under Administrative Code Chapter 37; providing for
25 the levy and collection of taxes to pay both principal and interest on such Bonds;

1 incorporating the provisions of the Administrative Code relating to the Citizens'
2 General Obligation Bond Oversight Committee's review of Affordable Housing Bond
3 expenditures; setting certain procedures and requirements for the election; adopting
4 findings under the California Environmental Quality Act; and finding that the
5 proposed Bonds are in conformity with the General Plan, and with the eight priority
6 policies of Planning Code, Section 101.1(b). (Board File Nos. 190495 & 190501)
7 (Mayor Breed)

- 8 ▪ Initiative Ordinance amending the Business and Tax Regulations Code and
9 Administrative Code to impose an excise tax on the net rider fares for rides
10 facilitated by commercial ride-share companies and rides provided by autonomous
11 vehicles and private transit services vehicles, to fund transportation operations and
12 infrastructure for traffic congestion mitigation in the City; and to increase the City's
13 appropriations limit by the amount collected under the tax for four years from
14 November 5, 2019. (Board File No. 190584) (Mayor Breed)
- 15 ▪ Initiative Ordinance submitted by four or more Supervisors to the voters, entitled
16 "Ordinance amending the Planning Code to create the 100 Percent Affordable
17 Housing and Educator Housing Streamlining Program; to allow affordable housing
18 and affordable teacher housing in Public zoning districts; and to provide timelines
19 for the review and approval of affordable housing and affordable teacher housing."
20 (Board File No. 190720) (Supervisor Fewer)
- 21 ▪ Initiative Ordinance submitted by four or more Supervisors to the voters, entitled
22 "Ordinance amending the Campaign and Governmental Conduct Code to prohibit
23 campaign contributions from limited liability companies and limited liability
24 partnerships; prohibit campaign contributions to members of and candidates for the
25 Board of Supervisors, the Mayor and candidates for Mayor, the City Attorney and

1 candidates for City Attorney, and the controlled committees of those officials and
2 candidates, from any person with pending or recently resolved land use matters
3 before the City; and expand disclaimer requirements for independent expenditure
4 committee advertisements." (Board File No. 190723) (Supervisor Mar)

12 later than the deadline of noon, August 15, 2019, and the respective rebuttal
13 proponent/opponent ballot arguments no later than noon, August 19, 2019; now, therefore, be

16 sponsor listed above, under Municipal Elections Code, Sections 530 and 550, to prepare and
17 submit written proponent/opponent ballot arguments and respective rebuttal
18 proponent/opponent ballot arguments on the listed measures as referenced; and, be it

19 FURTHER MOVED, That the Board Members or sponsor who are authorized by this
20 Motion to prepare and submit proponent/opponent ballot arguments, may authorize or assign
21 to any other person(s) under Municipal Elections Code, Section 550(c) and (d), to prepare and
22 submit the proponent/opponent's ballot arguments and/or respective rebuttal arguments.
