11 Section 4. The Teacher and Early Care Educator Reserve established above shall be
12 appropriated by the Board of Supervisors to sustain wages for early care educators and
13 SFUSD teachers and staff in Fiscal Year 2020-2021 if other City revenues or SFUSD
14 revenues or legally available reserves are not sufficient to do so. Such appropriations shall be
15 considered on an annual basis and adopted no later than August 15th of each year. The
16 Controller shall transfer any unspent balance on June 30, 2021 to a reserve for one-time
17 expenditures, or at such time that the Board of Supervisors determines, by ordinance, that this
18 Reserve is no longer required to meet these needs given other funds appropriated in the City
19 and/or School District's Fiscal Year 2019-2020 and/or 2020-2021 budgets. Funds
20 appropriated from this Reserve shall be considered General Fund advances and administered
21 per the provisions in sections 10 and 12 below.

22
23 Section 5. Funds appropriated above are sufficient to sustain investments in various ongoing
24 homeless and behavioral health services through Fiscal Year 2019-20. It is the intent of the
25 Board of Supervisors to ensure that these expenditures are sustained for Fiscal Years 2020-

1 2021 and 2021-2022 through the subsequent appropriation of Excess ERAF or other
2 revenues received in Fiscal Year 2019-2020.

3
4 Section 4.6. Uses appropriations of ~~\$220,545,896~~ \$220,551,322 in Sections 2, Baseline
5 appropriations, and appropriations in Section 3 for affordable housing, homelessness and
6 behavioral health services, early care and education, utility acquisition assessment, and
7 SFUSD Teacher compensation 3 above are hereby placed on Controller's Reserve pending
8 confirmation of cash flow timing from the State of California.

9
10 Section 5.7. The Controller is authorized to establish and adjust work orders for services
11 provided by the Department of Public Health, the Human Services Agency, the Department of
12 Homelessness and Supportive Housing, the Department of Children, Youth and Their
13 Families, and the Mayor's Office of Housing and Community Development.

14
15 Section 6.8. The Controller is authorized to record transfers between funds and adjust work
16 orders and the accounting treatment of sources and uses appropriated in this Ordinance as
17 necessary to conform with Generally Accepted Accounting Principles and other laws.

18
19 Section 79. Appropriations General Fund appropriations for the subsections above for
20 affordable housing, and homelessness and behavioral health services are hereby provided as
21 General Fund advances to implement the programs specified in the Homelessness Gross
22 Receipts Tax Ordinance, and will be spent consistently with the provisions of the
23 Homelessness Gross Receipts Tax Ordinance. The programs specified in the Homelessness
24 Gross Receipts Tax Ordinance are funded by the dedicated Homelessness Gross Receipts
25 Tax, which is subject to legal challenge and is therefore not available for appropriation at this

1 time. At such time that the legal issue is resolved and the Homelessness Gross Receipts Tax
2 revenues are deemed available for appropriation, the Controller is directed to repay these
3 advances using the accumulated balances of the Homelessness Gross Receipts Tax.
4

5 Section 810. Appropriations General Fund appropriations for the subsection above for
6 \$13,500,000 for San Francisco Unified School District teacher compensation investment, are
7 hereby provided as General Fund advances to implement the School District Parcel Tax
8 Ordinance and will be spent consistently with the provisions of the School District Parcel Tax
9 Ordinance. The programs specified in the School District Parcel Tax Ordinance are funded by
10 the dedicated School District Parcel Tax Ordinance, which is subject to legal challenge and is
11 therefore not available for appropriation at this time. At such time that the legal issue is
12 resolved and the School District Parcel Tax Ordinance revenues are deemed available for
13 appropriation, the Controller is directed to repay these advances using the accumulated
14 balances of the School District Parcel Tax Ordinance.
15

16 Section 911. Appropriations General Fund appropriations for the subsection above for Public
17 Power and Energy Efficiency a Utility Acquisition Assessment are hereby provided as
18 General Fund advances to ~~implement public power and energy efficiency projects and shall~~
19 ~~be spent consistently with San Francisco Public Utilities Commission Revenue Bond~~
20 ~~provisions complete that work~~, and shall be reimbursed upon issuance of future San
21 Francisco Public Utilities Commission Revenue Bonds if permissible. At such time that future
22 revenue bonds are issued and are deemed available for appropriation, the Controller is
23 directed to repay these advances using San Francisco Public Utilities Commission Revenue
24 Bond proceeds.
25

1 Section 4012. General Fund appropriations Appropriations for the subsection above for Early
2 Childhood Care Educator Wage Adjustments and Reimbursement Rate Increases are hereby
3 provided as General Fund advances to implement childcare and early education projects and
4 shall be spent consistently with the Commercial Rent Tax for Childcare and Early Education
5 Ordinance, which is subject to legal challenge and is therefore not available for appropriation
6 at this time. At such time that the legal issue is resolved and the Commercial Rent Tax for
7 Childcare and Early Education Ordinance revenues are deemed available for appropriation,
8 the Controller is directed to repay these advances using the accumulated balances of the
9 Commercial Rent Tax for Childcare and Early Education Ordinance.


10
11 Section 13. The following departments shall provide a written report to the Board of
12 Supervisors in June 2019 regarding the use of excess ERAF appropriations, including specific
13 information on the programs that were implemented with the funds, program participation, and
14 program performance: Mayor's Office of Housing and Community Development, Department
15 of Homelessness and Supportive Housing, Department of Public Health, Human Services
16 Agency Office of Early Care and Education, Department of Children, Youth and Their
17 Families, Department of Public Works, and the San Francisco Public Utilities Commission.


